# ROOT OF UNITY QUANTUM CLUSTER ALGEBRAS AND DISCRIMINANTS

#### Abstract

We describe a connection between the subjects of cluster algebras and discriminants. For this, we define the notion of root of unity quantum cluster algebras and prove that they are polynomial identity algebras. Inside each such algebra we construct a (large) canonical central subalgebra, which can be viewed as a far reaching generalization of the central subalgebras of big quantum groups constructed by De Concini, Kac and Procesi and used in representation theory. Each such central subalgebra is proved to be isomorphic to the underlying classical cluster algebra of geometric type. When the root of unity quantum cluster algebra is free over its central subalgebra, we prove that the discriminant of the pair is a product of powers of the frozen variables times an integer. An extension of this result is also proved for the discriminants of all subalgebras generated by the cluster variables of nerves in the exchange graph. These results can be used for the effective computation of discriminants. As an application we prove an explicit formula for the discriminant of the integral form over $\mathbb{Z}[\varepsilon]$ of each quantum uniponet cells of De Concini, Kac and Procesi for arbitrary symmetrizable Kac-Moody algebras.


## 1. Introduction

1.1. Cluster algebras and discriminants. Cluster algebras were introduced by Fomin and Zelevinsky in [12] and since then, they have played a fundamental role in a number of diverse areas such as representation theory, combinatorics, Poisson and algebraic geometry, mathematical physics, and others $[15,32]$.

Discriminants of number fields were defined by Dedekind in the 1870s. They have proven an invaluable tool in number theory, algebraic geometry, combinatorics, and orders in central simple algebras [21, 34, 35]. In more recent years, new applications of discriminants have been found in the noncommutative setting. Bell, Ceken, Palmieri, Wang and Zhang used the discriminant as an invariant in determining the automorphism groups of certain polynomial identity algebras $[6,7]$ and to address the the Zariski cancellation problem (when $A[t] \simeq B[t]$ implies $A \simeq B)[1]$. Discriminant ideals are also intrinsically related to the representation theory of the corresponding noncommutative algebra [5].

In this paper we connect the subjects of cluster algebras and discriminants. We define the notion of root of unity quantum cluster algebra, show that these algebras are polynomial identity (PI) algebras, and construct a canonical large central subalgebra in each of them which is shown to be isomorphic to the underlying classical cluster algebra. These special central subalgebras can be viewed as far reaching generalizations of the De Concini-KacProcesi central subalgebras of big quantum groups $[10,11]$. We prove a theorem giving an explicit formula for the discriminant of a root of unity quantum cluster algebra, and apply it to compute the discriminants of the big quantum unipotent cells for all symmetrizable Kac-Moody algebras at roots of unity.

[^0]1.2. Root of unity quantum cluster algebras. Let $\varepsilon^{1 / 2}$ be a primitive $\ell$-th root of unity for a positive integer $\ell$. We define a root of unity quantum cluster algebra by constructing mutations in the skew field of fraction of the based quantum torus over $\mathbb{Z}\left[\varepsilon^{1 / 2}\right]$ with basis $\left\{X^{f} \mid f \in \mathbb{Z}^{N}\right\}$ and relations

X^{f} X^{g}=\varepsilon^{\Lambda(f, g) / 2} X^{f+g}, \quad \forall f, g \in \mathbb{Z}^{N}
$$
for a skew-symmetric bilinear form $\Lambda: \mathbb{Z}^{N} \times \mathbb{Z}^{N} \rightarrow \mathbb{Z}_{\ell}:=\mathbb{Z} / \ell \mathbb{Z}$. Quantum frames $M_{\varepsilon}$ are introduced in this setting as in the quantum setting of Berenstein and Zelevinsky [4], but weaker compatibility assumptions between the bilinear form $\Lambda$ and the exchange matrix $\widetilde{B}$ are imposed (Definition 3.2). In particular, $\widetilde{B}$ need no longer have a full rank as the quantum case in [4]. A subset inv of the exchange indices ex is allowed to be inverted and the corresponding $\mathbb{Z}\left[\varepsilon^{1 / 2}\right]$-algebra generated by all cluster variables and the inverses of the frozen ones in inv is denoted by $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}\right.$, inv) (Definition 3.7).

In the special case of $\ell=1$ this construction exactly recovers the definition of a classical cluster algebra of geometric type. Quantum Weyl algebras and quantum unipotent cells at roots of unity for all symmetrizable Kac-Moody algebras are examples of root of unity quantum cluster algebras (Sect. 5.6 and 8.3). In addition to the standard properties of classical and quantum cluster algebras, such as the Laurent phenomenon, we prove the following key results for the algebras $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ :
Theorem A. Let $\varepsilon^{1 / 2}$ be a primitive $\ell$-th root of unity for a positive integer $\ell$.
(1) All root of unity quantum cluster algebras $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ are polynomial identity algebras (see [31, Ch. 13]).
(2) The subring of $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ generated by the $\ell$-th powers of all cluster variables and the inverses of the $\ell$-th powers of the frozen ones in inv is in the center of $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$. If $\ell$ is odd and coprime to the entries of the symmetrizing diagonal matrix for the principal part of $\widetilde{B}$, this subring is isomorphic to the corresponding classical cluster algebra $\mathbf{A}(\widetilde{B}, \mathbf{i n v})$.
(3) Under the assumption in part (2) the exchange graphs of $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ and $\mathbf{A}(\widetilde{B}, \mathbf{i n v})$ are canonically isomorphic.
Denote by

$$
\begin{equation*}
\mathbf{C}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right) \tag{1.1}
\end{equation*}
$$

the $\mathbb{Z}\left[\varepsilon^{1 / 2}\right]$-extension of the subring of $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}\right.$, inv $)$ in part (2) of the theorem. In concrete important situations $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}\right.$, inv $)$ is module finite over $\mathbf{C}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ (Sect. 6.4 and 8.3). For quantum unipotent cells at roots of unity, the latter is proved to be precisely the special De Concini-Kac-Procesi subalgebra [11]. The punchline of part (2) of the theorem is that it not only constructs a large central subalgebra in vast generality, but it also gives a full control on it via cluster theory. As an upshot, the representation theory of the algebras in [11] can be studied within the framework of root of unity and classical cluster algebras.

The proof of part (3) uses a different strategy from the Berenstein-Zelevinsky [4] result for the isomorphism between classical and quantum exchange graphs. It is based on the special central subalgebras from part (2).

Root of unity quantum cluster algebras do not necessarily arise as specializations of quantum cluster algebras. For instance, in the case $\ell=1$ we recover all cluster algebras of geometric type. For these reasons we introduce a subclass of strict root of unity quantum cluster algebras, defined as those for which the skew-symmetric bilinear form $\Lambda: \mathbb{Z}^{N} \times \mathbb{Z}^{N} \rightarrow \mathbb{Z}_{\ell}$ comes from a skew-symmetric bilinear form $\mathbb{Z}^{N} \times \mathbb{Z}^{N} \rightarrow \mathbb{Z}$ which is compatible with the exchange matrix $\widetilde{B}$ in the sense of [4]. In the case $\ell=1$, that notion
is the same as the notion of a classical cluster algebra with a compatible Poisson structure in the sense of Gekhtman-Shapiro-Vainshtein [22]. If the quantum cluster algebra for $\widetilde{B}$ equals the corresponding upper quantum cluster algebra, then we prove that the root of unity $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ arises as a specialization from a quantum cluster algebra (Sect. 5). This gives an effective tool for the construction of root of unity quantum cluster algebras (Sect. 5.6 and 8.3).
1.3. Discriminants. Knowing the explicit form of the discriminant of a noncommutative algebra has a number of important applications, but its calculation is very difficult. Only a few results are known to date and they concern concrete classes of algebras. Skewpolynomial algebras were treated in [6, 7], their Veronese subrings in [9], low dimension Artin-Schelter regular algebras in $[1,37,38]$, Ore extensions without skew-derivations and skew group extensions in [17], quantized Weyl algebras in [8, 29], Taft algebra smash products in [18] and others. A Poisson geometric method for computing discriminants via deformation theory was given in [33].

We prove the following general results for the computation of the discriminants of all root of unity quantum cluster algebras over their special central subalgebras (1.1) arising from Theorem A(2):
Theorem B. Let $\varepsilon^{1 / 2}$ be a primitive $\ell$-th root of unity and $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ be a root of unity quantum cluster algebra such that $\ell$ is odd and coprime to the entries of the skewsymmetrizing diagonal matrix for the principal part of $\widetilde{B}$. Let $\Theta$ be any collection of seeds that is a nerve (in the sense of [16] and Definition 6.4) and $\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v}), \mathbf{A}(\Theta$, inv ) (resp. $\left.\mathbf{C}_{\varepsilon}(\Theta, \mathbf{i n v})\right)$ be the subalgebras of $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right), \mathbf{A}(\widetilde{B}, \mathbf{i n v})\left(\right.$ resp. $\left.\mathbf{C}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)\right)$ generated by the cluster variables from the seeds in $\Theta$ (resp. their $\ell$-th powers).
(1) If $\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v})$ is a free module over $\mathbf{C}_{\varepsilon}(\Theta, \mathbf{i n v})$, then $\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v})$ is a finite rank $\mathbf{C}_{\varepsilon}(\Theta, \mathbf{i n v})$-module of rank $\ell^{N}$ and its discriminant with respect to the regular trace function is given by

d\left(\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v}) / \mathbf{C}_{\varepsilon}(\Theta, \mathbf{i n v})\right)=\mathbf{c}_{\varepsilon}(\Theta, \mathbf{i n v})^{\times} \ell^{N \ell^{N}} \prod_{i \in[1, N] \backslash(\mathbf{e x} \sqcup \mathbf{i n v})} X_{i}^{\ell a_{i}} \text { for some } a_{i} \in \mathbb{N},
$$

where $X_{i}$ denote the frozen variables of $\mathbf{A}_{\varepsilon}(\Theta$, inv $)$ and $\mathbb{N}:=\{0,1, \ldots\}$.
(2) If $\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v})$ is a free module over $\mathbf{A}(\Theta, \mathbf{i n v})$, then $\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v})$ is a finite rank $\mathbf{A}(\Theta, \mathbf{i n v})$-module of rank $\ell^{N} \varphi(\ell)$ and its discriminant with respect to the regular trace function is given by

d\left(\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v}) / \mathbf{A}(\Theta, \mathbf{i n v})\right)=_{\mathbf{A}(\Theta, \mathbf{i n v}) \times}\left(\frac{\ell^{(N+1) \varphi(\ell)}}{\prod_{p \mid \ell} p^{\varphi(\ell) /(p-1)}}\right)_{i \in[1, N] \backslash(\mathbf{e x} \sqcup \mathbf{i n v})}^{\ell^{N}} \prod_{i}^{\ell c_{i}} \text { for some } c_{i} \in \mathbb{N},
$$

where $\varphi($.$) denotes Euler's \varphi$-function.
In the theorem one can choose $\Theta$ to be the set of all seeds, which gives a formula for the discriminant of $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ over $\mathbf{C}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$. The choice of any nerve $\Theta$ in the collection of all seeds allows for the extra flexibility in computing discriminants of subalgebras of root of unity quantum cluster algebras that do not have cluster structures on their own. The very specific form of the discriminant in the theorem makes the computation of the integers $a_{i}$ easy by degree and filtration arguments (see e.g. Sect. 8.5).
1.4. The De Concini-Kac-Procesi quantum unipotent cells. Many PI algebras are secretly root of unity quantum cluster algebras or, more generally, algebras of the form $\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v})$. Let $\mathfrak{g}$ be an arbitrary symmetrizable Kac-Moody algebra and $w$ a Weyl group element. In Theorem 8.4 we prove that this is the case for the integral forms over $\mathbb{Z}[\varepsilon]$ of
all big quantum unipotent cells $A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathbb{Z}[\varepsilon]}$ of De Concini-Kac-Procesi [11], namely that $A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathbb{Z}[\varepsilon]} \otimes_{\mathbb{Z}[\varepsilon]} \mathbb{Z}\left[\varepsilon^{1 / 2}\right]$ admits the structure of a root of unity quantum cluster algebra. Using Theorem B, we prove:

Theorem C. For all symmetrizable Kac-Moody algebras $\mathfrak{g}$, Weyl group elements $w$ and primitive $\ell$-th roots of unity $\varepsilon$ such that $\ell$ is odd and coprime to the symmetrizing integers of the Cartan matrix of $\mathfrak{g}$, the discriminant of the integral form of the corresponding quantum unipotent cell $A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathbb{Z}[\varepsilon]}$ over its De Concini-Kac-Procesi central subalgebra $C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathbb{Z}[\varepsilon]}$ with respect to the regular trace is given by

$$
d\left(A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathbb{Z}[\varepsilon]} / C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathbb{Z}[\varepsilon]}\right)==_{\mathbb{Z}[\varepsilon] \times} \ell^{\left(N \ell^{N}\right)} \prod_{i \in \mathcal{S}(w)} \bar{D}_{\varpi_{i}, w \varpi_{i}}^{\ell^{N}(\ell-1)},
$$

where $\mathcal{S}(w)$ is the support of $w$ and $\bar{D}_{\varpi_{i}, w \varpi_{i}}$ are the standard unipotent quantum minors in $A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathbb{Z}[\varepsilon]}$ associated to the fundamental weights $\varpi_{i}$.
A special and weaker case of this theorem was proved in [33]. It only dealt with the case of finite dimensional simple Lie algebras $\mathfrak{g}$, due to the use of Poisson geometric results from [10, 11]. Furthermore, [33] only applied to the case of discriminants of algebras over $\mathbb{C}(\varepsilon)$ and not over $\mathbb{Z}[\varepsilon]$, because of the use of Poisson geometric techniques.

Notation, We will use the following notation throughout the paper. For a pair of integers $j \leq k$, denote $[j, k]:=\{j, j+1, \ldots, k\}$. For a pair of positive integers $m, n$, denote $0_{m \times n}$ the zero matrix of size $m \times n$.

## 2. Preliminaries on classical and quantum cluster algebras

In this section we gather background material on cluster algebras of geometric type and quantum cluster algebras which will be used in the rest of the paper.
2.1. Cluster algebras of geometric type. Cluster algebras were defined by Fomin and Zelevinsky in [12]. Let $N$ be a positive integer, ex be a subset of $[1, N]$, and $\mathcal{F}$ be a purely transcendental extension of $\mathbb{Q}$ of transcendence degree $N$. A pair $(\widetilde{\mathbf{x}}, \widetilde{B})$ is called a seed if
(1) $\widetilde{\mathbf{x}}=\left\{x_{1}, \ldots, x_{N}\right\}$ is a transcendence basis of $\mathcal{F}$ over $\mathbb{Q}$ which generates $\mathcal{F}$;
(2) $\widetilde{B} \in M_{N \times \mathbf{e x}}(\mathbb{Z})$ and its ex $\times$ ex submatrix $B$ (called the principal part of $\widetilde{B}$ ) is skewsymmetrizable; that is $D B$ is skew-symmetric for a matrix $D=\operatorname{diag}\left(d_{j}, j \in \mathbf{e x}\right)$ with $d_{j} \in \mathbb{Z}_{+}$.
We call $\widetilde{B}$ the exchange matrix of the seed, $\widetilde{\mathbf{x}}$ the cluster of the seed, $x_{i}$ the cluster variables. The subset ex $\subseteq[1, N]$ is called set of exchangeable indices. The columns of $\widetilde{B}$ are indexed by this set. The mutation of $\widetilde{B}$ in direction $k \in \mathbf{e x}$ is given by

\mu_{k}(\widetilde{B})=\left(b_{i j}^{\prime}\right):= \begin{cases}-b_{i j} & \text { if } i=k \text { or } j=k \\ b_{i j}+\frac{\left|b_{i k}\right| b_{k j}+b_{i k}\left|b_{k j}\right|}{2} & \text { otherwise. }\end{cases}
$$

Equivalently, $\mu_{k}(\widetilde{B})=E_{s} \widetilde{B} F_{s}$ where $s= \pm$ is a sign and the matrices $E_{s} \in M_{N}(\mathbb{Z})$, $F_{s} \in M_{\mathrm{ex}}(\mathbb{Z})$ are defined by

E_{s}:=\left(e_{i j}\right)=\left\{\begin{array}{ll}
\delta_{i j} & \text { if } j \neq k \\
-1 & \text { if } i=j=k \\
\max \left(0,-s b_{i k}\right) & \text { if } i \neq j=k,
\end{array} \quad F_{s}:=\left(f_{i j}\right)= \begin{cases}\delta_{i j} & \text { if } i \neq k \\
-1 & \text { if } i=j=k \\
\max \left(0, s b_{k j}\right) & \text { if } j \neq i=k .\end{cases}\right.

The principal part of $\mu_{k}(\widetilde{B})$ is the mutation $\mu_{k}(B)$ of the principal part $B$ of $\widetilde{B}$ and the matrix $\mu_{k}(B)$ is skew-symmetrizable with respect to the same diagonal matrix $D$ that skewsymmetrizes $B,[12]$. Mutation $\mu_{k}$ of the seed ( $\left.\widetilde{\mathbf{x}}, \widetilde{B}\right)$ in the direction of $k \in \mathbf{e x}$ is given by $\mu_{k}(\widetilde{\mathbf{x}}, \widetilde{B}):=\left(\widetilde{\mathbf{x}}^{\prime}, \mu_{k}(\widetilde{B})\right)$ where the mutation of $\widetilde{\mathbf{x}}$ is given by

\begin{equation*}
\widetilde{\mathbf{x}}^{\prime}=\left\{x_{k}^{\prime}\right\} \cup \widetilde{\mathbf{x}} \backslash\left\{x_{k}\right\} \quad \text { and } \quad x_{k} x_{k}^{\prime}:=\prod_{b_{i k}>0} x_{i}^{b_{i k}}+\prod_{b_{i k}<0} x_{i}^{-b_{i k}} . \tag{2.1}

Mutation is an involution, $\mu_{k}^{2}=\mathrm{id}$, [12]. We say that two seeds ( $\left.\widetilde{\mathbf{x}}^{\prime}, \widetilde{B}^{\prime}\right)$, ( $\widetilde{\mathbf{x}}^{\prime \prime}, \widetilde{B}^{\prime \prime}$ ) are mutation-equivalent if ( $\widetilde{\mathbf{x}}^{\prime \prime}, \widetilde{B}^{\prime \prime}$ ) can be obtained from ( $\widetilde{\mathbf{x}}^{\prime}, \widetilde{B}^{\prime}$ ) via a finite sequence of mutations. Denote this by $\left(\widetilde{\mathbf{x}}^{\prime}, \widetilde{B}^{\prime}\right) \sim\left(\widetilde{\mathbf{x}}^{\prime \prime}, \widetilde{B}^{\prime \prime}\right)$. All seeds that are mutation-equivalent to ( $\widetilde{\mathbf{x}}, \widetilde{B}$ ) contain the cluster variables $\mathbf{c}:=\left\{x_{i} \mid i \in[1, N] \backslash \mathbf{e x}\right\}$, called the frozen variables.

The cluster algebra $\mathbf{A}(\widetilde{B})$ is defined as the $\mathbb{Z}\left[\mathbf{c}^{ \pm 1}\right]$-subalgebra of $\mathcal{F}$ generated by all cluster variables in the seeds $\left(\widetilde{\mathbf{x}}^{\prime}, \widetilde{B}^{\prime}\right) \sim(\widetilde{\mathbf{x}}, \widetilde{B})$. For the purposes of applications to coordinate rings, instead of inverting all frozen variables, we often need to pick a subset inv $\subseteq[1, N] \backslash \mathbf{e x}$ to invert. Then $\mathbf{A}(\widetilde{B}, \mathbf{i n v})$, denotes the $\mathbb{Z}\left[\mathbf{c}, x_{k}^{-1}, k \in \mathbf{i n v}\right]$-subalgebra generated by all cluster variables in the seeds $\left(\widetilde{\mathbf{x}}^{\prime}, \widetilde{B}^{\prime}\right) \sim(\widetilde{\mathbf{x}}, \widetilde{B})$. In particular, $\mathbf{A}(\widetilde{B})=\mathbf{A}(\widetilde{B},[1, N] \backslash \mathbf{e x})$.

The upper cluster algebra $\mathbf{U}(\widetilde{B}, \mathbf{i n v})$ is the intersection of all mixed polynomial/Laurent polynomial subrings

$$
\mathbb{Z}\left[x_{1}^{\prime}, \ldots, x_{N}^{\prime}\right]\left[\left(x_{i}^{\prime}\right)^{-1}, i \in \mathbf{i n v}\right]
$$

of $\mathcal{F}$ for the seeds $\left(\left(x_{1}^{\prime}, \ldots, x_{N}^{\prime}\right), \widetilde{B}^{\prime}\right) \sim(\widetilde{\mathbf{x}}, \widetilde{B})$. The Laurent phenomenon of Fomin-Zelevinsky [13] established that $\mathbf{A}(\widetilde{B}, \mathbf{i n v}) \subseteq \mathbf{U}(\widetilde{B}$, inv $)$.
2.2. Quantum cluster algebras. Quantum cluster algebras were defined by Berenstein and Zelevinsky in [4]. Let $\Lambda: \mathbb{Z}^{N} \times \mathbb{Z}^{N} \rightarrow \mathbb{Z}$ be a skew-symmetric bilinear form. By abuse of notation we will denote its matrix in the standard basis $e_{1}, \ldots, e_{N}$ of $\mathbb{Z}^{N}$ by the same symbol $\Lambda=\left(\Lambda\left(e_{i}, e_{j}\right)\right)$, and we will use interchangeably both notions. The bilinear form is uniquely reconstructed from this matrix. Using a formal variable $q^{1 / 2}$, we work with the Laurent polynomial ring

$$
\begin{equation*}
\mathcal{A}_{q}^{1 / 2}:=\mathbb{Z}\left[q^{ \pm 1 / 2}\right] . \tag{2.2}
\end{equation*}
$$

Definition 2.1. The based quantum torus $\mathcal{T}_{q}(\Lambda)$ associated with $\Lambda$ is defined as the $\mathcal{A}_{q}^{1 / 2}$ algebra with a $\mathcal{A}_{q}^{1 / 2}$-basis $\left\{X^{f} \mid f \in \mathbb{Z}^{N}\right\}$ and multiplication given by

$$
X^{f} X^{g}=q^{\Lambda(f, g) / 2} X^{f+g}, \quad \text { where } \quad f, g \in \mathbb{Z}^{N} .
$$

The bilinear form $\Lambda$ can be recovered from the commutation relations of the generators $X^{e_{1}}, \ldots, X^{e_{N}}$ of $\mathcal{T}_{q}(\Lambda)$, because $X^{f} X^{g}=q^{\Lambda(f, g)} X^{g} X^{f}$. We denote by $\mathcal{F}$ the skew-field of fractions of $\mathcal{T}_{q}(\Lambda)$, which is a $\mathbb{Q}\left(q^{1 / 2}\right)$-algebra. Each $\sigma \in G L_{N}(\mathbb{Z})$ gives rise to the based quantum torus $\mathcal{T}_{q}\left(\Lambda^{\prime}\right)$ associated to the form $\Lambda^{\prime}(f, g)=\Lambda(\sigma f, \sigma g)$. Note that if we consider $\Lambda^{\prime}$ as a matrix, then $\Lambda^{\prime}=\sigma^{\top} \Lambda \sigma$. Also, we have an $\mathcal{A}_{q}^{1 / 2}$-algebra isomorphism $\Psi_{\sigma}: \mathcal{T}_{q}(\Lambda) \rightarrow \mathcal{T}_{q}\left(\Lambda^{\prime}\right)$ given by $X^{f} \mapsto X^{\sigma^{-1} f}$.
Definition 2.2. Let $\mathcal{F}_{q}$ be a division algebra over $\mathbb{Q}\left(q^{1 / 2}\right)$. A toric frame $M_{q}$ for $\mathcal{F}_{q}$ is defined as a map $M_{q}: \mathbb{Z}^{N} \rightarrow \mathcal{F}_{q}$ for which there exists a skew-symmetric matrix $\Lambda \in M_{N}(\mathbb{Z})$ satisfying:
(1) There is an $\mathcal{A}_{q}^{1 / 2}$-algebra embedding $\phi: \mathcal{T}_{q}(\Lambda) \hookrightarrow \mathcal{F}_{q}$ with $\phi\left(X^{f}\right)=M_{q}(f)$ for all $f \in \mathbb{Z}^{N}$.
(2) $\mathcal{F}_{q}=\operatorname{Fract}\left(\phi\left(\mathcal{T}_{q}(\Lambda)\right)\right)$.

The skew-symmetric matrix associated to a toric frame $M_{q}$ will be denoted by $\Lambda_{M_{q}}$. For any $\sigma \in G L_{N}(\mathbb{Z}), \rho \in \operatorname{Aut}\left(\mathcal{F}_{q}\right)$, and toric frame $M_{q}$, the map $\rho M_{q} \sigma$ is a toric frame with $\Lambda_{\rho M_{q} \sigma}=\sigma^{\top} \Lambda \sigma$. The embedding $\phi$ for $M_{q}$ gives rise to an embedding $\phi^{\prime}: \mathcal{T}_{q}\left(\Lambda_{\rho M_{q} \sigma}\right) \hookrightarrow \mathcal{F}_{q}$ by $\phi^{\prime}=\rho \circ \phi \circ \Psi_{\sigma^{-1}}$, which satisfies the two properties above for $\rho M_{q} \sigma$.

For a toric frame $M_{q}$, we indicate the based quantum torus that lies in $\mathcal{F}_{q}$ with basis $\left\{M_{q}(f) \mid f \in \mathbb{Z}^{N}\right\}$ by $\mathcal{T}_{q}\left(M_{q}\right)$. We have the canonical isomorphism $\mathcal{T}_{q}\left(M_{q}\right) \simeq \mathcal{T}_{q}\left(\Lambda_{M_{q}}\right)$.

As in the previous subsection fix ex $\subseteq[1, N]$. View $\Lambda=\left(\lambda_{i j}\right)$ as a skew-symmetric matrix and let $\widetilde{B}$ be an $N \times$ ex matrix. We call the pair $(\Lambda, \widetilde{B})$ compatible if

$$
\begin{equation*}
\sum_{k=1}^{N} b_{k j} \lambda_{k i}=\delta_{i j} d_{j} \text { for all } i \in[1, N], j \in \mathbf{e x} \tag{2.3}
\end{equation*}
$$

for some $d_{j} \in \mathbb{Z}_{+}$. Equivalently $\widetilde{B}^{\top} \Lambda=\widetilde{D}$ where $d_{j j}=d_{j}$ for $j \in$ ex and otherwise $d_{i j}=0$. Denote by $D:=\operatorname{diag}\left(d_{j}, j \in \mathbf{e x}\right)$ the principal part of $\widetilde{D}$. If $(\Lambda, \widetilde{B})$ is a compatible pair, then $\widetilde{B}$ has full rank and its principle part $B$ is skew-symmetrized by $D,[4]$

A pair $(\Lambda, \widetilde{B})$ is mutated in the direction of $k \in \mathbf{e x}$, by setting $\mu_{k}(\Lambda, \widetilde{B}):=\left(\Lambda^{\prime}, \widetilde{B}^{\prime}\right)$ where $\widetilde{B^{\prime}}=E_{s} \widetilde{B} F_{s}$ as in the classical case and $\Lambda^{\prime}:=E_{s}^{\top} \Lambda E_{s}$, which is independent on the choice of sign $s$, [4]. As in the classical case $\mu_{k}$ is an involution, [4].

We call a pair $\left(M_{q}, \widetilde{B}\right)$ (consisting of a toric frame $M_{q}$ for a division algebra $\mathcal{F}_{q}$ and a matrix $\left.\widetilde{B} \in M_{N \times \mathbf{e x}}(\mathbb{Z})\right)$ a quantum seed if the pair $\left(\Lambda_{M_{q}}, \widetilde{B}\right)$ is compatible. We call $\left\{M_{q}\left(e_{j}\right) \mid j \in[1, N]\right\}$ the cluster variables of the seed $\left(M_{q}, \widetilde{B}\right)$. The subset of cluster variables $\left\{M_{q}\left(e_{j}\right) \mid j \notin \mathbf{e x}\right\}$ are called frozen variables.

Proposition 2.3. Suppose $M_{q}$ is a toric frame, $k \in[1, N]$ and $g=\left(n_{1}, \ldots, n_{N}\right) \in \mathbb{Z}^{N}$ is such that $\Lambda_{M_{q}}\left(g, e_{j}\right)=0$ for $j \neq k$ and $n_{k}=0$. Then for each $s= \pm$, there is an automorphism $\rho_{g, s}=\rho_{g, s}^{M_{q}}$ of $\mathcal{F}_{q}$, such that

$$
\rho_{g, s}\left(M_{q}\left(e_{j}\right)\right)= \begin{cases}M_{q}\left(e_{k}\right)+M_{q}\left(e_{k}+s g\right) & \text { if } j=k \\ M_{q}\left(e_{j}\right) & \text { if } j \neq k .\end{cases}
$$

This is a variation of [4, Proposition 4.2], proved in [23, Lemma 2.8], which will be more suitable for our root of unity treatment and its relation to the quantum picture via the homomorphism (5.3).

Mutation $\mu_{k}\left(M_{q}, \widetilde{B}\right)$ of a quantum seed in the direction of $k \in \mathbf{e x}$ is defined as

$$
\left(\mu_{k}\left(M_{q}\right), \mu_{k}(\widetilde{B})\right):=\left(\rho_{b^{k}, s}^{M_{q}} M_{q} E_{s}, E_{s} \widetilde{B} F_{s}\right),
$$

which is independent on the choice of sign, and $\Lambda_{\mu_{k}\left(M_{q}\right)}=\mu_{k}\left(\Lambda_{M_{q}}\right)$, [4]. Explicitly, mutation of toric frames is given by

$$
\begin{align*}
& \mu_{k}\left(M_{q}\right)\left(e_{j}\right)=M_{q}\left(e_{j}\right) \text { for } j \neq k, \\
& \mu_{k}\left(M_{q}\right)\left(e_{k}\right)=M_{q}\left(-e_{k}+\left[b^{k}\right]_{+}\right)+M_{q}\left(-e_{k}-\left[b^{k}\right]_{-}\right), \tag{2.4}
\end{align*}
$$

[4]. Here, for $b=\left(b_{1}, \ldots, b_{N}\right) \in \mathbb{Z}^{N}$, set $[b]_{ \pm}:=\left(c_{1}, \ldots, c_{N}\right) \in \mathbb{Z}^{N}$ where $c_{i}:=b_{i}$ if $\pm b_{i} \geq 0$ and $c_{i}:=0$ otherwise.

We fix a subset inv $\subseteq[1, N] \backslash$ ex corresponding to frozen variables that will be inverted.
Definition 2.4. The quantum cluster algebra $\mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right)$ is the $\mathcal{A}_{q}^{1 / 2}$-subalgebra of $\mathcal{F}_{q}$ generated by all cluster variables $M_{q}^{\prime}\left(e_{j}\right), j \in[1, N]$ of quantum seeds $\left(M_{q}^{\prime}, \widetilde{B}^{\prime}\right)$ mutation equivalent to $\left(M_{q}, \widetilde{B}\right)$ and by the inverses $M_{q}\left(e_{j}\right)^{-1}$ for $j \in \mathbf{i n v}$.

The upper quantum cluster algebra $\mathbf{U}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right)$ is defined as the intersection over quantum seeds $\left(M_{q}^{\prime}, \widetilde{B^{\prime}}\right) \sim\left(M_{q}, \widetilde{B}\right)$ of all $\mathcal{A}_{q}^{1 / 2}$-subalgebras of $\mathcal{F}_{q}$ of the form

$$
\mathcal{A}_{q}^{1 / 2}\left\langle M_{q}^{\prime}\left(e_{i}\right), M_{q}^{\prime}\left(e_{j}\right)^{-1} \mid i \in[1, N], j \in \mathbf{e x} \sqcup \mathbf{i n v}\right\rangle .
$$

These subalgebras of $\mathcal{F}_{q}$ are called mixed quantum tori.
The quantum Laurent phenomenon states that

$$
\mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right) \subseteq \mathbf{U}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right) .
$$

Berenstein and Zelevinsky [4] proved this in the case when all frozen variables are inverted, i.e., when inv $=[1, N] \backslash \mathbf{e x}$. The general case was proved in [23, Theorem 2.5], where the result is stated over $\mathbb{C}\left(q^{ \pm 1 / 2}\right)$ but the proof works over $\mathcal{A}_{q}^{1 / 2}$.

The exchange graphs of a cluster algebra $\mathbf{A}(\widetilde{\mathbf{x}}, \widetilde{B})$ and a quantum cluster algebra $\mathbf{A}_{q}\left(M_{q}, \widetilde{B}\right)$ are the labelled graphs with vertices corresponding to seeds mutation-equivalent to ( $\widetilde{\mathbf{x}}, \widetilde{B}$ ), respectively $\left(M_{q}, \widetilde{B}\right)$, and edges given by seed mutation and labelled by the corresponding mutation number. Those graphs will be denoted by $E(\widetilde{B})$ and $E_{q}\left(\Lambda_{M_{q}}, \widetilde{B}\right)$. A map between two labelled graphs is a graph map that preserves labels of edges. Berenstein and Zelevinsky [4] proved that there is a (unique) isomorphism between the exchange graphs $E_{q}\left(\Lambda_{M_{q}}, \widetilde{B}\right)$ and $E(\widetilde{B})$ obtained by sending the vertex corresponding to seed $(\widetilde{\mathbf{x}}, \widetilde{B})$ to that of $\left(M_{q}, \widetilde{B}\right)$. Obviously, the exchange graphs do not depend on the choice of inverted set inv.

## 3. Root of unity quantum cluster algebras and elementary properties

In this section we define root of unity quantum cluster algebras and describe their elementary properties that are similar to those for quantum cluster algebras. We furthermore prove that all of them are PI algebras.
3.1. Construction. Let $\ell$ be a positive integer. Set

$$
\mathbb{Z}_{\ell}:=\mathbb{Z} / \ell \mathbb{Z}
$$

For a matrix $C \in M_{n \times m}(\mathbb{Z})$ denote its image in $M_{n \times m}\left(\mathbb{Z}_{\ell}\right)$ by $\bar{C}$. Let $\varepsilon^{1 / 2} \in \mathbb{C}$ be a primitive $\ell$-th root of unity and set

$$
\begin{equation*}
\mathcal{A}_{\varepsilon}^{1 / 2}:=\mathbb{Z}\left[\varepsilon^{1 / 2}\right] . \tag{3.1}
\end{equation*}
$$

Note that in the case of $\ell$ odd, $\varepsilon$ is also a primitive $\ell$-th root of unity and $\mathbb{Z}\left[\varepsilon^{1 / 2}\right]=\mathbb{Z}[\varepsilon]$.
By abuse of notation, for a skew-symmetric bilinear form $\Lambda: \mathbb{Z}^{N} \times \mathbb{Z}^{N} \rightarrow \mathbb{Z}_{\ell}$ we will denote by the same letter its matrix $\left(\Lambda\left(e_{i}, e_{j}\right)\right) \in M_{N}\left(\mathbb{Z}_{\ell}\right)$. For such a bilinear form define the root of unity based quantum torus $\mathcal{T}_{\varepsilon}(\Lambda)$ to be the $\mathcal{A}_{\varepsilon}^{1 / 2}$-algebra with an $\mathcal{A}_{\varepsilon}^{1 / 2}$-basis $\left\{X^{f} \mid f \in \mathbb{Z}^{N}\right\}$ and multiplication given by

$$
X^{f} X^{g}=\varepsilon^{\Lambda(f, g) / 2} X^{f+g} \quad \text { where } \quad f, g \in \mathbb{Z}^{N} .
$$

Hence $X^{f} X^{g}=\varepsilon^{\Lambda(f, g)} X^{g} X^{f}$. The bilinear form $\Lambda$ can be recovered from the based quantum torus by

$$
\varepsilon^{\Lambda(f, g) / 2}=X^{f} X^{g} X^{-f-g}, \quad \forall f, g \in \mathbb{Z}^{N}
$$

by using the assumption that $\varepsilon$ is a primitive $\ell$-th root of unity.
Definition 3.1. A root of unity toric frame $M_{\varepsilon}$ of a division algebra $\mathcal{F}_{\varepsilon}$ over $\mathbb{Q}\left(\varepsilon^{1 / 2}\right)$ is a map $M_{\varepsilon}: \mathbb{Z}^{N} \rightarrow \mathcal{F}_{\varepsilon}$ such that there is a skew-symmetric matrix $\Lambda \in M_{N}\left(\mathbb{Z}_{\ell}\right)$ satisfying the following conditions:
(1) There is an $\mathcal{A}_{\varepsilon}^{1 / 2}$-algebra embedding $\phi: \mathcal{T}_{\varepsilon}(\Lambda) \hookrightarrow \mathcal{F}_{\varepsilon}$ with $\phi\left(X^{f}\right)=M_{\varepsilon}(f)$ for all $f \in \mathbb{Z}^{N}$.
(2) $\mathcal{F}_{\varepsilon} \simeq \operatorname{Fract}\left(\mathcal{T}_{\varepsilon}(\Lambda)\right)$.

The matrix $\Lambda \in M_{N}\left(\mathbb{Z}_{\ell}\right)$ is uniquely reconstructed from the root of unity toric frame $M_{\varepsilon}$. It will be called matrix of the frame $M_{\varepsilon}$ and we will denote $\Lambda_{M_{\varepsilon}}:=\Lambda$.

Fix a subset of $\mathbf{e x} \subseteq[1, N]$.
Definition 3.2. Let $\widetilde{B} \in M_{N \times \mathbf{e x}}(\mathbb{Z})$ and $\Lambda=\left(\lambda_{i j}\right) \in M_{N}\left(\mathbb{Z}_{\ell}\right)$ be skew-symmetric. The pair $(\Lambda, \widetilde{B})$ will be called $\ell$-compatible if there exists a diagonal matrix $D:=\operatorname{diag}\left(d_{j}, j \in \mathbf{e x}\right)$ with $d_{j} \in \mathbb{Z}_{+}$such that
(1) The principal part $B$ of $\widetilde{B}$ is skew-symmetrized by $D$; that is $D B$ is skew-symmetric.
(2) $\sum_{k=1}^{N} \bar{b}_{k j} \lambda_{k i}=\delta_{i j} \bar{d}_{j}(\bmod \ell)$ for all $i \in[1, N], j \in \mathbf{e x}$; that is $\Lambda^{\top} \overline{\widetilde{B}}=\left[\begin{array}{c}\bar{D} \\ 0\end{array}\right]$, where 0 denotes the zero matrix of size $([1, N] \backslash \mathbf{e x}) \times \mathbf{e x}$.
We will not require any conditions on $\bar{d}_{j}$, so the matrix $\widetilde{B}$ need not have full rank like in the case of quantum cluster algebras.

Similar to the generic case, we define the mutation in direction $k \in \mathbf{e x}$ of $\ell$-compatible pairs to be

$$
\mu_{k}(\Lambda, \widetilde{B}):=\left(\bar{E}_{s}^{\top} \Lambda \bar{E}_{s}, E_{s} \widetilde{B} F_{s}\right) \text { for a choice of sign } s
$$

The proof of the following proposition is analogous to [4, Propositions 3.4 and 3.6].
Proposition 3.3. The pair $\mu_{k}(\Lambda, \widetilde{B})$ is independent of the choice of sign s. If the pair $(\Lambda, \widetilde{B})$ is $\ell$-compatible with respect to a diagonal matrix $D$, then the pair $\mu_{k}(\Lambda, \widetilde{B})$ is also $\ell$-compatible with respect to the same diagonal matrix $D$. Mutation $\mu_{k}$ of $\ell$-compatible pairs is an involution.
Definition 3.4. We will call a pair $\left(M_{\varepsilon}, \widetilde{B}\right)$ a root of unity quantum seed if
(1) $M_{\varepsilon}$ is a root of unity toric frame of $\mathcal{F}_{\varepsilon}$,
(2) $\widetilde{B} \in M_{N \times \mathbf{e x}}(\mathbb{Z})$ and $\left(\Lambda_{M_{\varepsilon}}, \widetilde{B}\right)$ is an $\ell$-compatible pair.

Proposition 3.5. Suppose $M_{\varepsilon}$ is a root of unity toric frame, $k \in[1, N]$, and $g=\left(n_{1}, \ldots, n_{N}\right) \in$ $\mathbb{Z}^{N}$ is such that $\Lambda_{M_{\varepsilon}}\left(g, e_{j}\right) \equiv 0(\bmod \ell)$ for $j \neq k$ and $n_{k}=0$. Then for each $s= \pm$, there is a unique automorphism $\rho_{g, s}^{M_{\varepsilon}}$ of $\mathcal{F}_{\varepsilon}$, such that

$$
\rho_{g, s}^{M_{\varepsilon}}\left(M_{\varepsilon}\left(e_{j}\right)\right)= \begin{cases}M_{\varepsilon}\left(e_{k}\right)+M_{\varepsilon}\left(e_{k}+s g\right) & \text { if } j=k  \tag{3.2}\\ M_{\varepsilon}\left(e_{j}\right) & \text { if } j \neq k\end{cases}
$$

Our argument is similar to [23, Lemma 2.8] but we spell out the details because they will be needed later.

Proof. Denote $\operatorname{Fract}\left(\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right)\right)$ by $\mathcal{F}_{\varepsilon}$. We have a homomorphism $\rho_{g, s}: \mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right) \rightarrow \mathcal{F}_{\varepsilon}$ since

$$
\left(M_{\varepsilon}\left(e_{k}\right)+M_{\varepsilon}\left(e_{k}+s g\right)\right) M_{\varepsilon}\left(e_{j}\right)=\varepsilon^{\Lambda\left(e_{k}, e_{j}\right)} M_{\varepsilon}\left(e_{j}\right)\left(M_{\varepsilon}\left(e_{k}\right)+M_{\varepsilon}\left(e_{k}+s g\right)\right)
$$

for $j \neq k$. On the $\mathcal{A}_{\varepsilon}^{1 / 2}$-basis $\left\{M_{\varepsilon}(f)\right\}$, one calculates that

$$
\rho_{g, s}\left(M_{\varepsilon}(f)\right)= \begin{cases}P_{g, s, m}^{M_{\varepsilon}, m_{k}} M_{\varepsilon}(f) & \text { if } m_{k} \geq 0 \\ \left(P_{g, s,-}^{M_{\varepsilon},-m_{k}}\right)^{-1} M_{\varepsilon}(f) & \text { if } m_{k}<0\end{cases}
$$

for $f=\left(m_{1}, \ldots, m_{N}\right) \in \mathbb{Z}^{N}$, where

$$
P_{g, s, \pm}^{M_{\varepsilon}, m_{k}}:=\prod_{p=1}^{m_{k}}\left(1+\varepsilon^{\mp s(2 p-1) \Lambda_{M_{\varepsilon}}\left(g, e_{k}\right) / 2} M_{\varepsilon}(s g)\right) \text { for } m_{k} \geq 0
$$

Let $G:=\mathcal{A}_{\varepsilon}^{1 / 2}\left[M_{\varepsilon}(s g)\right] \backslash\{0\} \subset \mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right)$. Note that $G \cdot M_{\varepsilon}(f)=M_{\varepsilon}(f) \cdot G$ for any $f \in$ $\mathbb{Z}^{N}$, and hence $G$ is an Ore set. Moreover, as $\operatorname{im}\left(\rho_{g, s}\right) \subset \mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right) G^{-1}$, we may consider $\rho_{g, s}: \mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right) \rightarrow \mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right) G^{-1}$. Since $g$ has $n_{k}=0$, the map $\rho_{g, s}$ acts by the identity on $G$. We can clearly extend the map to an endomorphism $\rho_{g, s}: T_{\varepsilon}\left(M_{\varepsilon}\right) G^{-1} \rightarrow T_{\varepsilon}\left(M_{\varepsilon}\right) G^{-1}$.

We can similarly construct an algebra endomorhpism $\rho_{g, s}^{\prime}: T_{\varepsilon}\left(M_{\varepsilon}\right) G^{-1} \rightarrow T_{\varepsilon}\left(M_{\varepsilon}\right) G^{-1}$ defined by

$$
\rho_{g, s}^{\prime}\left(M_{\varepsilon}\left(e_{j}\right)\right)=\left\{\begin{array}{ll}
\left(P_{g, s,+}^{M_{\varepsilon}, 1}\right)^{-1} M_{\varepsilon}(f) & \text { if } j=k \\
M_{\varepsilon}\left(e_{j}\right) & \text { if } j \neq k
\end{array} .\right.
$$

Clearly $\rho_{g, s}$ and $\rho_{g, s}^{\prime}$ are inverse to each other and are automorphisms of $T_{\varepsilon}\left(M_{\varepsilon}\right) G^{-1}$. In particular, they are injective and can be extended to automorphisms of $\mathcal{F}_{\varepsilon}$. Uniqueness follows since $M_{\varepsilon}\left(e_{j}\right)$ are skew-field generators of $\mathcal{F}_{\varepsilon}$.

Similar to the generic case, we define mutation of a root of unity quantum seed $\left(M_{\varepsilon}, \widetilde{B}\right)$ in the direction of $k \in \mathbf{e x}$ by

$$
\begin{equation*}
\mu_{k}\left(M_{\varepsilon}, \widetilde{B}\right):=\left(\rho_{b^{\varepsilon}, s}^{M_{\varepsilon} E_{s}} M_{\varepsilon} E_{s}, E_{s} \widetilde{B} F_{s}\right) . \tag{3.3}
\end{equation*}
$$

The proof of the following proposition is analogous to [4, Propositions 4.7 and 4.10].
Proposition 3.6. Given a root of unity quantum seed $\left(M_{\varepsilon}, \widetilde{B}\right)$, the following hold:
(1) For $k \in \mathbf{e x}$ and either sign $s= \pm$ :

$$
\begin{aligned}
& \rho_{b^{\varepsilon}, s}^{M_{s} E_{s}} M_{\varepsilon} E_{s}\left(e_{j}\right)=M_{\varepsilon}\left(e_{j}\right) \text { for } j \neq k, \\
& \rho_{b_{\varepsilon}, s}^{M_{\varepsilon} E_{s}} M_{\varepsilon} E_{s}\left(e_{k}\right)=M_{\varepsilon}\left(-e_{k}+\left[b^{k}\right]_{+}\right)+M_{\varepsilon}\left(-e_{k}-\left[b^{k}\right]_{-}\right) .
\end{aligned}
$$

In particular, mutation does not depend on the sign used.
(2) $\mu_{k}\left(M_{\varepsilon}, \widetilde{B}\right)$ is also a root of unity quantum seed.

Moreover, mutation is an involution.
We consider the equivalence classes under finite sequences of mutations of root of unity quantum seeds. Fix a subset inv $\subseteq[1, N] \backslash \mathbf{e x}$ corresponding to frozen variables that will set as invertible.
Definition 3.7. Given a root of unity quantum seed $\left(M_{\varepsilon}, \widetilde{B}\right)$, we define the quantum cluster algebra at a root of unity $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ as the $\mathcal{A}_{\varepsilon}^{1 / 2}$-subalgebra of $\mathcal{F}_{\varepsilon}$ generated by all cluster variables of quantum seeds $\left(M_{\varepsilon}^{\prime}, \widetilde{B}^{\prime}\right)$ mutation equivalent to $\left(M_{\varepsilon}, \widetilde{B}\right)$ and by the inverses of the frozen variables corresponding to inv,

$$
\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right):=\mathcal{A}_{\varepsilon}^{1 / 2}\left\langle M_{\varepsilon}^{\prime}\left(e_{i}\right), M_{\varepsilon}\left(e_{j}\right)^{-1} \mid i \in[1, N], j \in \mathbf{i n v},\left(M_{\varepsilon}^{\prime}, \widetilde{B}^{\prime}\right) \sim\left(M_{\varepsilon}, \widetilde{B}\right)\right\rangle .
$$

We have associated to each skew-symmetric bilinear form $\Lambda$ a based quantum torus. Given subsets ex and inv, we can also associate an algebra in between the corresponding skew-polynomial algebra and the quantum torus,

$$
\begin{equation*}
\mathcal{T}_{\varepsilon}(\Lambda)_{\geq}:=\mathcal{A}_{\varepsilon}^{1 / 2}\left\langle X_{i}, X_{j}^{-1} \mid i \in[1, N], j \in \mathbf{e x} \sqcup \mathbf{i n v}\right\rangle \subset \mathcal{T}_{\varepsilon}(\Lambda) \tag{3.4}
\end{equation*}
$$

We call this a mixed based quantum torus. Equivalently, it is the algebra

$$
\left\{\oplus \mathcal{A}_{\varepsilon}^{1 / 2} X^{f} \mid f \in \mathbb{Z}_{\geq}^{N}\right\} \quad \text { with the product } \quad X^{f} X^{g}=\varepsilon^{\Lambda(f, g) / 2} X^{f+g}, \forall f, g \in \mathbb{Z}_{\geq}^{N},
$$

where

$$
\begin{equation*}
\mathbb{Z}_{\geq}^{N}:=\left\{f=\left(f_{1}, \ldots, f_{N}\right) \in \mathbb{Z}^{N} \mid f_{i} \geq 0, \forall i \notin \mathbf{e x} \sqcup \mathbf{i n v}\right\} . \tag{3.5}
\end{equation*}
$$

We similarly define

$$
\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right)_{\geq}:=\left\langle M_{\varepsilon}\left(e_{i}\right), M_{\varepsilon}\left(e_{j}\right)^{-1} \mid i \in[1, N], j \in \mathbf{e x} \sqcup \mathbf{i n v}\right\rangle \subset \mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right)
$$

Definition 3.8. Given a root of unity quantum seed $\left(M_{\varepsilon}, \widetilde{B}\right)$ and specified subsets ex and inv, we define the upper quantum cluster algebra at a root of unity $\mathbf{U}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ as the intersection of mixed quantum tori corresponding to quantum seeds mutation equivalent to $\left(M_{\varepsilon}, \widetilde{B}\right)$,

$$
\mathbf{U}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right):=\bigcap_{\left(M_{\varepsilon}, \widetilde{B}\right) \sim\left(M_{\varepsilon}^{\prime}, \widetilde{B}^{\prime}\right)} \mathcal{T}_{\varepsilon}\left(M_{\varepsilon}^{\prime}\right)_{\geq} .
$$

Remark 3.9. In the case when $\varepsilon^{1 / 2}=1$ (i.e. $\ell=1$ ), a root of unity quantum cluster algebra can be identified with a classical cluster algebra (of geometric type)

$$
\mathbf{A}_{1}\left(M_{1}, \widetilde{B}, \mathbf{i n v}\right)=\mathbf{A}\left(\left(M_{1}\left(e_{1}\right), \ldots, M_{1}\left(e_{N}\right)\right), \widetilde{B}, \mathbf{i n v}\right)
$$

and similarly a root of unity upper quantum cluster algebra with an upper cluster algebra

$$
\mathbf{U}_{1}\left(M_{1}, \widetilde{B}, \mathbf{i n v}\right)=\mathbf{U}\left(\left(M_{1}\left(e_{1}\right), \ldots, M_{1}\left(e_{N}\right)\right), \widetilde{B}, \mathbf{i n v}\right)
$$

### 3.2. The quantum Laurent phenomenon at roots of unity.

Theorem 3.10. For any root of unity quantum cluster algebra $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$

$$
\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right) \subseteq \mathbf{U}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right) .
$$

Proof. The case when $\widetilde{B}$ has full rank is proved analogously to [23, Theorem 2.15]. We deduce the general case of the theorem from the full rank one as follows.

For simplicity of notation, assume that $\mathbf{e x}=[1, n]$ for some integer $n \leq N$. Consider the augmented skew-symmetric bilinear form with matrix

$$
\Lambda_{\text {aug }}:=\left[\begin{array}{cc}
\Lambda & 0_{N \times n} \\
0_{n \times N} & 0_{n \times n}
\end{array}\right],
$$

where $0_{i \times j}$ denotes the zero matrix of size $i \times j$. Denote the augmented exchange matrix

$$
\widetilde{B}_{\text {aug }}:=\left[\begin{array}{c}
\widetilde{B} \\
I_{n}
\end{array}\right]
$$

whose principal part is the same as $\widetilde{B}$. The pair $\left(\Lambda_{\text {aug }}, \widetilde{B}_{\text {aug }}\right)$ is $\ell$-compatible with respect to the same diagonal matrix $D$ because

$$
\overline{\widetilde{B}}_{\text {aug }}^{\top} \Lambda_{\text {aug }}=\left[\begin{array}{ll}
\bar{D} & 0
\end{array}\right] .
$$

Denote by $\widehat{\mathcal{F}}_{\varepsilon}$ the skew-field $\operatorname{Fract}\left(\mathcal{T}_{\varepsilon}\left(\Lambda_{\text {aug }}\right)\right)$ and consider the toric frame $\left(M_{\varepsilon}\right)_{\text {aug }}$ with matrix $\Lambda_{\text {aug }}$ such that $\left(M_{\varepsilon}\right)_{\text {aug }}\left(e_{k}\right):=X_{k}$ for all $k \in[N+1, N+n]$. Clearly, $\left(\left(M_{\varepsilon}\right)_{\text {aug }}, \widetilde{B}_{\text {aug }}\right)$ is a root of unity quantum seed. We have a canonical surjective $\mathcal{A}_{\varepsilon}^{1 / 2}$-algebra homomorphism

$$
\pi: \mathcal{T}_{\varepsilon}\left(\left(M_{\varepsilon}\right)_{\mathrm{aug}}\right)_{\geq} \rightarrow \mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right)_{\geq} \text {given by } \pi\left(\left(M_{\varepsilon}\right)_{\mathrm{aug}}\left(e_{k}\right)\right):= \begin{cases}M_{\varepsilon}\left(e_{k}\right), & 1 \leq k \leq N \\ 1, & N<k \leq N+n\end{cases}
$$

because the elements $\left(M_{\varepsilon}\right)_{\text {aug }}\left(e_{k}\right)$ are in the center of $\mathcal{T}_{\varepsilon}\left(\left(M_{\varepsilon}\right)_{\text {aug }}\right) \geq$ for $N<k \leq N+n$.
By induction on $m \geq 0$ one easily shows that

$$
\pi\left(\mu_{i_{1}} \ldots \mu_{i_{m}}\left(\left(M_{\varepsilon}\right)_{\text {aug }}\right)\left(e_{k}\right)\right)=\mu_{i_{1}} \ldots \mu_{i_{m}}\left(M_{\varepsilon}\right)\left(e_{k}\right)
$$

for all $k \in[1, N]$. Since the matrix $\widetilde{B}_{\text {aug }}$ has full rank, by the validity of the root of unity quantum Laurent phenomenon in the full rank case we have

$$
\mu_{i_{1}} \ldots \mu_{i_{m}}\left(\left(M_{\varepsilon}\right)_{\text {aug }}\right)\left(e_{k}\right) \in \mathcal{T}_{\varepsilon}\left(\left(M_{\varepsilon}\right)_{\text {aug }}\right)_{\geq}
$$

Hence, $\mu_{i_{1}} \ldots \mu_{i_{m}}\left(M_{\varepsilon}\right)\left(e_{k}\right) \in \mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right) \geq$ for all $k \in[1, N]$, which completes the proof of the theorem in the general case.

### 3.3. PI properties of root of unity quantum cluster algebras.

Theorem 3.11. All root of unity quantum cluster algebras $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ and root of unity upper quantum cluster algebras $\mathbf{U}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ are PI domains.
Proof. By Theorem 3.10, for every toric frame $M_{\varepsilon}$ of $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}\right.$, inv $)$ we have the embeddings

$$
\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right) \subseteq \mathbf{U}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right) \subseteq \mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right) \cong \mathcal{T}_{\varepsilon}\left(\Lambda_{M_{\varepsilon}}\right)
$$

Since each root of unity quantum torus $\mathcal{T}_{\varepsilon}(\Lambda)$ is a PI domain, the same is true for the first two algebras in the chain.

## 4. Canonical central subrings of root of unity quantum cluster algebras

The main results of this section are the construction of a canonical central subring of a root of unity quantum cluster algebra $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ and a theorem that it is isomorphic to the classical cluster algebra $\mathbf{A}(\widetilde{B}$, inv $)$.

### 4.1. Central embedding of commutative cluster algebras.

Lemma 4.1. If $\left(M_{\varepsilon}^{\prime}, \widetilde{B}^{\prime}\right)$ is mutation-equivalent to $\left(M_{\varepsilon}, \widetilde{B}\right)$, then the element $M_{\varepsilon}^{\prime}\left(e_{j}\right)^{l} \in$ $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ is central for any $j \in[1, N]$.
Proof. We only need show that $M_{\varepsilon}\left(e_{j}\right)^{l} \in Z\left(\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}\right)\right)$ for $j \in[1, N]$, since $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}\right.$, inv $)$ $=\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}^{\prime}, \widetilde{B}^{\prime}\right.$, inv $)$. Now $M_{\varepsilon}\left(e_{j}\right)^{l}$ is central in $\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right)$ as

$$
M_{\varepsilon}\left(e_{j}\right)^{l} M_{\varepsilon}(f)=M_{\varepsilon}\left(l e_{j}\right) M_{\varepsilon}(f)=\varepsilon^{\Lambda\left(l e_{j}, f\right)} M_{\varepsilon}(f) M_{\varepsilon}\left(l e_{j}\right)=M_{\varepsilon}(f) M_{\varepsilon}\left(e_{j}\right)^{l} .
$$

Thus, it is central in $\operatorname{Fract}\left(\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right)\right)$ and in $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$.
For a root of unity quantum seed $\left(M_{\varepsilon}, \widetilde{B}\right)$ and for $j \in \mathbf{e x}$, consider the commutation of elements $M_{\varepsilon}\left(-e_{j}+\left[b^{j}\right]_{+}\right)$and $M_{\varepsilon}\left(-e_{k}-\left[b^{j}\right]_{-}\right)$. The relation in the quantum torus is

$$
M_{\varepsilon}\left(-e_{j}-\left[b^{j}\right]_{-}\right) M_{\varepsilon}\left(-e_{j}+\left[b^{j}\right]_{+}\right)=\varepsilon^{\Lambda\left(-e_{j}-\left[b^{j}\right]_{-,-}, e_{j}+\left[b^{j}\right]_{+}\right)} M_{\varepsilon}\left(-e_{j}+\left[b^{j}\right]_{+}\right) M_{\varepsilon}\left(-e_{j}-\left[b^{j}\right]_{-}\right) .
$$

Set $t_{j}:=\Lambda\left(-e_{j}-\left[b^{j}\right]_{-},-e_{j}+\left[b^{j}\right]_{+}\right)$for brevity.
Lemma 4.2. Let $\left(M_{\varepsilon}, \widetilde{B}\right)$ be a root of unity quantum seed, so $\left(\Lambda_{M_{\varepsilon}}, \widetilde{B}\right)$ is an $\ell$-compatible pair with respect to a diagonal matrix $D=\operatorname{diag}\left(d_{j}, j \in \mathbf{e x}\right)$ with $d_{j} \in \mathbb{Z}_{+}$. Then for $j \in \mathbf{e x}$, $t_{j}=\bar{d}_{j}$.

Proof. We have that

$$
\begin{aligned}
t_{j} & =\Lambda\left(-e_{j}-\left[b^{j}\right]_{-},-e_{j}+\left[b^{j}\right]_{+}\right) \\
& =\Lambda\left(-e_{j},-e_{j}\right)+\Lambda\left(-e_{j},\left[b^{j}\right]_{+}\right)+\Lambda\left(-\left[b^{j}\right]_{-},-e_{j}\right)+\Lambda\left(-\left[b^{j}\right]_{-},\left[b^{j}\right]_{+}\right) \\
& =\Lambda\left(b^{j}, e_{j}\right)+\Lambda\left(\left[b^{j}\right]_{+},\left[b^{j}\right]_{-}\right)=\bar{d}_{j}+\Lambda\left(\left[b^{j}\right]_{+},\left[b^{j}\right]_{-}\right) .
\end{aligned}
$$

To evaluate $\Lambda\left(\left[b^{j}\right]_{+},\left[b^{j}\right]_{-}\right)$, we note that $b^{j}-\left[b^{j}\right]_{+}=\left[b^{j}\right]_{-}$, so

$$
\Lambda\left(\left[b^{j}\right]_{+},\left[b^{j}\right]_{-}\right)=\Lambda\left(\left[b^{j}\right]_{+}, b^{j}\right)-\Lambda\left(\left[b^{j}\right]_{+},\left[b^{j}\right]_{+}\right)=\Lambda\left(\left[b^{j}\right]_{+}, b^{j}\right) .
$$

Since $b_{j j}=0$,

$$
\Lambda\left(\left[b^{j}\right]_{+},\left[b^{j}\right]_{-}\right)=\Lambda\left(\left[b^{j}\right]_{+}, b^{j}\right)=\sum_{b_{i j}>0} b_{i j} \Lambda\left(e_{i}, b^{j}\right)=\sum_{b_{i j}>0}-b_{i j} \delta_{i, j} \bar{d}_{j}=0 .
$$

Thus $t_{j}=\bar{d}_{j}$.

We will often require the following condition on our root of unity quantum seed $\left(M_{\varepsilon}, \widetilde{B}\right)$ :

The condition (Coprime) only concerns the $\ell$-th root of unity $\varepsilon$ and the compatible pair $\left(\Lambda_{M_{\varepsilon}}, \widetilde{B}\right)$, and not the root of unity toric frame $M_{\varepsilon}$.

Remark 4.3. The diagonal matrix $D$ that skew-symmetrizes exchange matrices is not changed under mutation. Therefore, if a root of unity quantum seed satisfies condition (Coprime), then any mutation equivalent seed does so as well. So, (Coprime) is a condition on a root of unity quantum cluster algebra and not on individual seeds.

The main use of Lemma 4.2 is the following result. The formula appearing should be compared to the mutation relation of (2.1).
Proposition 4.4. Let $\left(M_{\varepsilon}, \widetilde{B}\right)$ be a root of unity quantum seed satisfying the condition (Coprime). Then for $k \in \mathbf{e x}$,

$$
M_{\varepsilon}\left(e_{k}\right)^{\ell}\left(\mu_{k} M_{\varepsilon}\left(e_{k}\right)\right)^{\ell}=\prod_{b_{i k}>0}\left(M_{\varepsilon}\left(e_{i}\right)^{\ell}\right)^{b_{i k}}+\prod_{b_{i k}<0}\left(M_{\varepsilon}\left(e_{i}\right)^{\ell}\right)^{-b_{i k}} .
$$

Proof. Denote

$$
Y:=M_{\varepsilon}\left(-e_{k}+\left[b^{k}\right]_{+}\right), Z:=M_{\varepsilon}\left(-e_{k}-\left[b^{k}\right]_{-}\right) \in \mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right) .
$$

Since $Z Y=\varepsilon^{d_{k}} Y Z$ (by Lemma 4.2) and $\varepsilon^{d_{k}}$ is an $\ell$-th primitive root of unity,

$$
(Y+Z)^{\ell}=Y^{\ell}+Z^{\ell}
$$

Thus,

$$
\begin{aligned}
\left(\mu_{k} M_{\varepsilon}\left(e_{k}\right)\right)^{\ell} & =\left(M_{\varepsilon}\left(-e_{k}+\left[b^{k}\right]_{+}\right)+M_{\varepsilon}\left(-e_{k}-\left[b^{k}\right]_{-}\right)\right)^{\ell}=(Y+Z)^{\ell} \\
& =M_{\varepsilon}\left(-e_{k}+\left[b^{k}\right]_{+}\right)^{\ell}+M_{\varepsilon}\left(-e_{k}-\left[b^{k}\right]_{-}\right)^{\ell} \\
& =M_{\varepsilon}\left(-\ell e_{k}+\ell\left[b^{k}\right]_{+}\right)+M_{\varepsilon}\left(-\ell e_{k}-\ell\left[b^{k}\right]_{-}\right) \\
& =M_{\varepsilon}\left(-\ell e_{k}\right) \prod_{b_{i k}>0} M_{\varepsilon}\left(\ell b_{i k} e_{i}\right)+M_{\varepsilon}\left(-\ell e_{k}\right) \prod_{b_{i k}<0} M_{\varepsilon}\left(-\ell b_{i k} e_{i}\right) .
\end{aligned}
$$

Example 4.5. The previous proposition does not hold if the condition that $\ell$ is coprime to the integers $d_{k}$ is dropped. Consider the following example when $\ell=9$. Let

$$
\varepsilon^{1 / 2}=e^{2 \pi i / 9}, \quad \Lambda=\left[\begin{array}{cc}
0 & 1 \\
-1 & 0
\end{array}\right], \quad \widetilde{B}=\left[\begin{array}{cc}
0 & 1 \\
-3 & 0
\end{array}\right] .
$$

Let $\mathcal{F}_{\varepsilon}:=\operatorname{Fract}\left(\mathcal{T}_{\varepsilon}(\Lambda)\right)$ and $M_{\varepsilon}: \mathbb{Z}^{2} \rightarrow \mathcal{F}_{\varepsilon}$ be the toric frame related to $\Lambda$ such that $M_{\varepsilon}(f)=X^{f}$ and $\Lambda_{M_{\varepsilon}}:=\Lambda$. Clearly, $\left(M_{\varepsilon}, \widetilde{B}\right)$ is a root of unity quantum seed. Here we have

$$
\widetilde{B}^{\top} \Lambda=\left[\begin{array}{ll}
3 & 0 \\
0 & 1
\end{array}\right] .
$$

In particular, $d_{1}=3$ is not coprime to $\ell=9$. For $Y:=M_{\varepsilon}\left(-e_{1}+\left[b^{1}\right]_{+}\right)=M_{\varepsilon}\left(-e_{1}\right)$ and $Z:=M_{\varepsilon}\left(-e_{1}-\left[b^{1}\right]_{-}\right)=M_{\varepsilon}\left(-e_{1}+3 e_{2}\right)$, by a direct computation one obtains

$$
(Y+Z)^{9}=Y^{9}+3 Y^{6} Z^{3}+3 Y^{3} Z^{6}+Z^{9} \neq Y^{9}+Z^{9}
$$

so the conclusion of Proposition 4.4 fails.

In a similar way, dropping the odd root of unity condition will result in a failure of the statement of Proposition 4.4. Consider the same choice for $\Lambda$ and $\widetilde{B}$, but with $\varepsilon^{1 / 2}=i$, a primitive fourth root of unity. Then $\varepsilon=-1$ and

$$
\begin{aligned}
(Y+Z)^{4} & =Y^{4}+\left(1+\varepsilon+2 \varepsilon^{2}+\varepsilon^{3}+\varepsilon^{4}\right) Y^{2} Z^{2}+Z^{4} \\
& =Y^{4}+2 Y^{2} Z^{2}+Z^{4} \neq Y^{4}+Z^{4}
\end{aligned}
$$

leading once again to a failure of the conclusion of Proposition 4.4. The issue in the even case is that $\varepsilon$ is a primitive $(\ell / 2)$-th root of unity, not a primitive $\ell$-th root of unity.

Define the $\mathbb{Z}$-subring

$$
\mathbf{C}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right):=\mathbb{Z}\left\langle M_{\varepsilon}^{\prime}\left(e_{i}\right)^{\ell}, M_{\varepsilon}^{\prime}\left(e_{j}\right)^{-\ell} \mid\left(M_{\varepsilon}^{\prime}, \widetilde{B}^{\prime}\right) \sim\left(M_{\varepsilon}, \widetilde{B}\right), i \in[1, N], j \in \operatorname{inv}\right\rangle
$$

of $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$.
Theorem 4.6. Suppose that $\left(M_{\varepsilon}, \widetilde{B}\right)$ satisfies condition (Coprime). Then the subring $\mathbf{C}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ of $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ is isomorphic to $\mathbf{A}(\widetilde{B}, \mathbf{i n v})$.
Proof. Since $\mathbf{A}\left(\left\{x_{1}, \ldots, x_{N}\right\}, \widetilde{B}, \varnothing\right)$ is constructed as a subalgebra of $\mathbb{Q}\left(x_{1}, \ldots, x_{N}\right)$, consider the isomorphism $\phi: \mathbb{Q}\left(x_{1}, \ldots, x_{N}\right) \rightarrow \operatorname{Fract}\left(\mathbb{Z}\left[M_{\varepsilon}\left(e_{1}\right)^{\ell}, \ldots, M_{\varepsilon}\left(e_{N}\right)^{\ell}\right]\right)$ given by $x_{j} \mapsto$ $M_{\varepsilon}\left(e_{j}\right)^{\ell}$. Proposition 4.4 gives us that $\phi\left(\mu_{i}\left(x_{j}\right)\right)=\left(\mu_{i} M_{\varepsilon}\left(e_{j}\right)\right)^{\ell}$ for all $i \in \mathbf{e x}, j \in[1, N]$. By induction on the length of the mutation sequence, $\phi\left(\mu_{i_{k}} \ldots \mu_{i_{1}}\left(x_{j}\right)\right)=\left(\mu_{i_{k}} \ldots \mu_{i_{1}} M_{\varepsilon}\left(e_{j}\right)\right)^{\ell}$.

Since the generators of $\mathbb{Z}\left\langle M_{\varepsilon}^{\prime}\left(e_{i}\right)^{\ell} \mid\left(M_{\varepsilon}^{\prime}, \widetilde{B}^{\prime}\right) \sim\left(M_{\varepsilon}, \widetilde{B}\right), i \in[1, N]\right\rangle$ are the images of the generators of $\mathbf{A}\left(\left\{x_{1}, \ldots, x_{N}\right\}, \widetilde{B}, \varnothing\right)$ under the isomorphism $\phi$, then we have an isomorphism of $\mathbb{Z}$-algebras. The more general case, when inv $\neq \varnothing$, is obtained by adjoining the appropriate inverses of frozen variables.
Corollary 4.7. If $\left(M_{\varepsilon}, \widetilde{B}\right)$ satisfies condition (Coprime), then the $\mathcal{A}_{\varepsilon}^{1 / 2}$-subalgebra

\begin{aligned}
& \mathbf{C}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right):= \\
& \mathcal{A}_{\varepsilon}^{1 / 2}\left\langle M_{\varepsilon}^{\prime}\left(e_{i}\right)^{\ell}, M_{\varepsilon}^{\prime}\left(e_{j}\right)^{-\ell} \mid\left(M_{\varepsilon}^{\prime}, \widetilde{B}^{\prime}\right) \sim\left(M_{\varepsilon}, \widetilde{B}\right), i \in[1, N], j \in \mathbf{i n v}\right\rangle
\end{aligned}
$$

of $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ is isomorphic to $\mathcal{A}_{\varepsilon}^{1 / 2} \otimes_{\mathbb{Z}} \mathbf{A}(\widetilde{B}, \mathbf{i n v})$.
4.2. Exchange graphs of root of unity quantum cluster algebras. For a root of unity quantum cluster algebra $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}\right)$, define its exchange graph $E_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}\right)$ to be the labelled graph with vertices corresponding to root of unity quantum seeds mutation-equivalent to $\left(M_{\varepsilon}, \widetilde{B}\right)$ and with edges given by seed mutation labelled by the corresponding letters.

Theorem 4.8. Let $\left(M_{\varepsilon}, \widetilde{B}\right)$ be a root of unity quantum seed satisfying condition (Coprime). There is a unique isomorphism of labelled graphs from the exchange graph $E_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}\right)$ to the exchange graph $E(\widetilde{B})$ which sends the vertex corresponding to the seed $\left(M_{\varepsilon}, \widetilde{B}\right)$ to the vertex corresponding to the seed $(\widetilde{\mathbf{x}}, \widetilde{B})$, where $\widetilde{\mathbf{x}}=\left(M_{\varepsilon}\left(e_{1}\right)^{\ell}, \ldots, M_{\varepsilon}\left(e_{N}\right)^{\ell}\right)$.

We will need the following two propositions for the proof of the theorem which are of independent interest. Recall that an exchange matrix $\widetilde{B}$ is indecomposable if it cannot be represented in a block diagonal form with blocks of strictly smaller size.

Proposition 4.9. Assume that $\left(M_{\varepsilon}, \widetilde{B}\right)$ and $\left(M_{\varepsilon}^{\prime}, \widetilde{B^{\prime}}\right)$ are two seeds of a root of unity quantum cluster algebra, where $\widetilde{B}$ is indecomposable and $\widetilde{B} \neq 0$. Then for every $k \in[1, N]$ there exists a functional $\theta: \mathbb{Z}^{N} \rightarrow \mathbb{Z}$ such that

$$
M_{\varepsilon}^{\prime}\left(e_{k}\right)=M_{\varepsilon}(f)+\sum_{i} a_{i} M_{\varepsilon}\left(f_{i}\right)
$$

for some $a_{i} \in \mathcal{A}_{\varepsilon}^{1 / 2}$ and $f, f_{i} \in \mathbb{Z}^{N}$ such that $\theta(f)>\theta\left(f_{i}\right)$ for all $i$.
The statment fails when $\widetilde{B}=0$, because in that case $\mu_{1}\left(M_{\varepsilon}\right)\left(e_{1}\right)=2 M_{\varepsilon}\left(-e_{1}\right)$.
Proof. We prove the proposition by induction on the distance between the vertices in the exchange graph corresponding to the seeds $\left(M_{\varepsilon}, \widetilde{B}\right)$ and $\left(M_{\varepsilon}^{\prime}, \widetilde{B^{\prime}}\right)$. The case when the distance equals 1 is trivial because the condition that $\widetilde{B}$ is indecomposable and $\widetilde{B} \neq 0$ implies that $\mu_{j}\left(M_{\varepsilon}\right)\left(e_{j}\right)=M_{\varepsilon}\left(f_{1}\right)+M_{\varepsilon}\left(f_{2}\right)$ for some $f_{1} \neq f_{2} \in \mathbb{Z}^{N}$.

Assume the validity of the statement when the distance equals $m$. Consider two seeds $\left(M_{\varepsilon}, \widetilde{B}\right)$ and $\left(M_{\varepsilon}^{\prime}, \widetilde{B}^{\prime}\right)$ whose vertices are at distance $m+1$ in the exchange graph. Then there exists a seed $\left(M_{\varepsilon}^{\prime \prime}, \widetilde{B}^{\prime \prime}\right)$ such that $\left(M_{\varepsilon}^{\prime \prime}, \widetilde{B}^{\prime \prime}\right)=\mu_{j}\left(M_{\varepsilon}, \widetilde{B}\right)$ for some $j \in[1, N]$ and the distance between the vertices of the exchange graph corresponding to the seeds $\left(M_{\varepsilon}^{\prime \prime}, \widetilde{B^{\prime \prime}}\right)$ and $\left(M_{\varepsilon}^{\prime}, \widetilde{B}^{\prime}\right)$ equals $m$. The exchange matrices $\widetilde{B}^{\prime}$ and $\widetilde{B}^{\prime \prime}$ are necessarily indecomposable. We have

$$
\begin{aligned}
& M_{\varepsilon}^{\prime \prime}\left(e_{l}\right)=M_{\varepsilon}\left(e_{l}\right) \text { for } l \neq j, \\
& M_{\varepsilon}^{\prime \prime}\left(e_{j}\right)=M_{\varepsilon}\left(-e_{j}+\left[b^{j}\right]_{+}\right)+M_{\varepsilon}\left(-e_{j}-\left[b^{j}\right]_{-}\right)
\end{aligned}
$$

By the induction hypothesis there exists a functional $\theta^{\prime \prime}: \mathbb{Z}^{N} \rightarrow \mathbb{Z}$ such that

$$
\begin{equation*}
M_{\varepsilon}^{\prime}\left(e_{k}\right)=M_{\varepsilon}^{\prime \prime}(g)+\sum_{i} a_{i}^{\prime \prime} M_{\varepsilon}^{\prime \prime}\left(g_{i}\right) \tag{4.1}
\end{equation*}
$$

for some $a_{i}^{\prime \prime} \in \mathcal{A}_{\varepsilon}^{1 / 2}$ and $g, g_{i} \in \mathbb{Z}^{N}$ such that $\theta^{\prime \prime}(g)>\theta^{\prime \prime}\left(g_{i}\right)$ for all $i$.
Denote by $s$ the sign $\pm$ for which $\theta^{\prime \prime}\left(\left[b^{j}\right]_{+}\right)$or $-\theta^{\prime \prime}\left(\left[b^{j}\right]_{-}\right)$is minimal. Define the functional $\theta: \mathbb{Z}^{N} \rightarrow \mathbb{Z}$ by

$$
\theta\left(e_{j}\right)=\theta^{\prime \prime}\left(-e_{j}+s\left[b^{j}\right]_{s}\right), \quad \theta\left(e_{l}\right)=\theta^{\prime \prime}\left(e_{l}\right) \text { for } l \neq j .
$$

Let $\widehat{\mathcal{T}}_{\varepsilon}\left(M_{\varepsilon}\right)$ be the completion of the quantum torus $\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right)$ spanned by formal sums of the form

$$
\sum_{m=0}^{\infty} c_{m} M_{\varepsilon}\left(h-m s b^{j}\right)
$$

for $h \in \mathbb{Z}^{N}$ and $c_{m} \in \mathcal{A}_{\varepsilon}^{1 / 2}$. It is an $\mathcal{A}_{\varepsilon}^{1 / 2}$-algebra on its own. We have $-s\left[b^{j}\right]_{-s}=s\left[b^{j}\right]_{s}-s b^{j}$. Since $M_{\varepsilon}\left(-e_{j}+\left[b^{j}\right]_{+}\right)$and $M_{\varepsilon}\left(-e_{j}-\left[b^{j}\right]_{-}\right)$skew-commute up to a power of $\varepsilon$, for all $n \in \mathbb{Z}$,

$$
\begin{align*}
M_{\varepsilon}^{\prime \prime}\left(n e_{j}\right) & =\left(M_{\varepsilon}\left(-e_{j}+s\left[b^{j}\right]_{s}\right)+M_{\varepsilon}\left(-e_{j}-s\left[b^{j}\right]_{-s}\right)\right)^{n}  \tag{4.2}\\
& =M_{\varepsilon}\left(n\left(-e_{j}+s\left[b^{j}\right]_{s}\right)\right)+\sum_{m=1}^{\infty} c_{m} M_{\varepsilon}\left(n\left(-e_{j}+s\left[b^{j}\right]_{s}\right)-m s b^{j}\right)
\end{align*}
$$

for some $c_{m} \in \mathcal{A}_{\varepsilon}^{1 / 2}$. Denote $\mathbb{Z}^{N-1}:=\oplus_{l \neq j} \mathbb{Z} e_{j} \subset \mathbb{Z}^{N}$. For all $h \in \mathbb{Z}^{N-1}$ we have

$$
\Lambda^{\prime \prime}\left(e_{j}, h\right)=\Lambda\left(-e_{j}+\left[b^{j}\right]_{+}, h\right)=\Lambda\left(-e_{j}-\left[b^{j}\right]_{-}, h\right)
$$

and thus, by using (4.2) and the definition of root of unity toric frames,

$$
\begin{equation*}
M_{\varepsilon}^{\prime \prime}\left(n e_{j}+h\right)=M_{\varepsilon}\left(n\left(-e_{j}+s\left[b^{j}\right]_{s}\right)+h\right)+\sum_{m=1}^{\infty} c_{m} M_{\varepsilon}\left(n\left(-e_{j}+s\left[b^{j}\right]_{s}\right)+h-m s b^{j}\right) \tag{4.3}
\end{equation*}
$$

for some $c_{m} \in \mathcal{A}_{\varepsilon}^{1 / 2}$. Write the elements $g, g_{i} \in \mathbb{Z}^{N}$ in (4.1) in the form $g=n e_{j}+h$, $g_{i}=n_{i} e_{j}+h_{i}$, for $n, n_{i} \in \mathbb{Z}, h, h_{i} \in \mathbb{Z}^{N-1}$ and apply (4.3) to obtain,

$$
\begin{aligned}
M_{\varepsilon}^{\prime}\left(e_{k}\right) & =M_{\varepsilon}\left(n\left(-e_{j}+s\left[b^{j}\right]_{s}\right)+h\right)+\sum_{m=1}^{\infty} c_{m} M_{\varepsilon}\left(n\left(-e_{j}+s\left[b^{j}\right]_{s}\right)+h-m s b^{j}\right) \\
& +\sum_{i} a_{i}^{\prime \prime} M_{\varepsilon}\left(n_{i}\left(-e_{j}+s\left[b^{j}\right]_{s}\right)+h_{i}\right)+\sum_{m=1}^{\infty} c_{i, m} M_{\varepsilon}\left(n_{i}\left(-e_{j}+s\left[b^{j}\right]_{s}\right)+h_{i}-m s b^{j}\right)
\end{aligned}
$$

for some $c_{i, m} \in \mathcal{A}_{\varepsilon}^{1 / 2}$. By the root of unity quantum Laurent phenomenon (Theorem 3.10), the sum in the right hand side belongs to $\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right)$. Furthermore, the definition of the functional $\theta$ implies that

$$
\begin{aligned}
& \theta\left(n\left(-e_{j}+s\left[b^{j}\right]_{s}\right)+h\right)=\theta^{\prime \prime}(g)>\theta^{\prime \prime}\left(g_{i}\right)=\theta\left(n_{i}\left(-e_{j}+s\left[b^{j}\right]_{s}\right)+h_{i}\right), \\
& \theta\left(s b^{j}\right)=\theta\left(s\left[b^{j}\right]_{s}\right)+\theta\left(s\left[b^{j}\right]_{-s}\right)<0 .
\end{aligned}
$$

Hence, the above expansion of $M_{\varepsilon}^{\prime}\left(e_{k}\right)$ in $\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right)$ has the desired properties with respect to the functional $\theta$.

Remark 4.10. The proof of Proposition 4.9 directly translates to the case quantum cluster algebras to yield the validity of the obvious analog of it in that situation.

Proposition 4.11. Assume that $\left(M_{\varepsilon}, \widetilde{B}\right)$ and $\left(M_{\varepsilon}^{\prime}, \widetilde{B}^{\prime}\right)$ are two seeds of a root of unity quantum cluster algebra. Then $\left(M_{\varepsilon}^{\prime}\left(e_{1}\right), \ldots, M_{\varepsilon}^{\prime}\left(e_{N}\right)\right)$ is a permutation of $\left(M_{\varepsilon}\left(e_{1}\right), \ldots, M_{\varepsilon}\left(e_{N}\right)\right)$ if and only if $\left(M_{\varepsilon}^{\prime}\left(e_{1}\right)^{\ell}, \ldots, M_{\varepsilon}^{\prime}\left(e_{N}\right)^{\ell}\right)$ is a permutation of $\left(M_{\varepsilon}\left(e_{1}\right)^{\ell}, \ldots, M_{\varepsilon}\left(e_{N}\right)^{\ell}\right)$.

Proof. The forward direction is obvious. For the reverse direction it is sufficient to consider the case when $\widetilde{B}$ is indecomposable. If $\widetilde{B}=0$, the statement is clear. In the remaining part we assume that $\widetilde{B}$ is indecomposable and $\widetilde{B} \neq 0$. Suppose that

$$
\begin{equation*}
M_{\varepsilon}^{\prime}\left(e_{k}\right)^{\ell}=M_{\varepsilon}\left(e_{\sigma(k)}\right)^{\ell} \quad \text { for some } \quad \sigma \in S_{N} . \tag{4.4}
\end{equation*}
$$

Consider a root of unity quantum torus $\mathcal{T}_{\varepsilon}(\Lambda)$ with generators $X_{1}^{ \pm 1}, \ldots, X_{N}^{ \pm 1}$. By using the standard basis of $\mathcal{T}_{\varepsilon}(\Lambda)$, one easily sees that the only solutions of the equation $y^{\ell}=X_{k}^{\ell}$ for $y \in \mathcal{T}_{\varepsilon}(\Lambda)$ and $1 \leq k \leq N$ are $y=\left(\varepsilon^{1 / 2}\right)^{m} X_{k}$ for $m \in[0, \ell)$. By Theorem 3.10, $M_{\varepsilon}^{\prime}\left(e_{k}\right) \in \mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right)$, and (4.4) implies that for all $1 \leq k \leq N$

$$
M_{\varepsilon}^{\prime}\left(e_{k}\right)=\left(\varepsilon^{1 / 2}\right)^{m_{k}} M_{\varepsilon}\left(e_{\sigma(k)}\right) \quad \text { for some } \quad m_{k} \in[0, \ell) .
$$

Proposition 4.9 implies that $m_{k}=0$ for all $1 \leq k \leq N$, so

$$
M_{\varepsilon}^{\prime}\left(e_{k}\right)=M_{\varepsilon}\left(e_{\sigma(k)}\right), \quad \forall 1 \leq k \leq N .
$$

Proof of Theorem 4.8. Any map of labelled graphs from $E_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}\right)$ to $E(\widetilde{B})$ that sends the vertex corresponding to the seed $\left(M_{\varepsilon}, \widetilde{B}\right)$ to the vertex corresponding to the seed $\left(\left(M_{\varepsilon}\left(e_{1}\right)^{\ell}, \ldots, M_{\varepsilon}\left(e_{N}\right)^{\ell}\right), \widetilde{B}\right)$ necessarily sends the vertex $\mu_{i_{1}} \ldots \mu_{i_{m}}\left(M_{\varepsilon}, \widetilde{B}\right)$ to the vertex $\mu_{i_{1}} \ldots \mu_{i_{m}}\left(\left(M_{\varepsilon}\left(e_{1}\right)^{\ell}, \ldots, M_{\varepsilon}\left(e_{N}\right)^{\ell}\right), \widetilde{B}\right)$ for all sequences $i_{1}, \ldots, i_{m}$ in ex. Proposition 4.11 implies that this map is well defined. It is obviously surjective. It is injective by Proposition 4.11.
4.3. The full centers of roots of unity quantum cluster algebras. In Corollary 4.7 we constructed a central subalgebra $\mathbf{C}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ of each root of unity quantum cluster algebra $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ satisfying condition (Coprime). We will call it the special central subalgebra. One can provide a characterization of the full center of the algebra $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$, as follows. For a skew-symmetric bilinear form $\Lambda: \mathbb{Z}^{N} \times \mathbb{Z}^{N} \rightarrow \mathbb{Z}_{\ell}$ denote

$$
\operatorname{Ker} \Lambda:=\left\{f \in \mathbb{Z}^{N} \mid \Lambda(f, g)=0, \forall g \in \mathbb{Z}^{N}\right\} .
$$

Proposition 4.12. Let $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ be a root of unity quantum cluster algebra. For every seed $\left(M_{\varepsilon}^{\prime}, \widetilde{B}^{\prime}\right) \sim\left(M_{\varepsilon}, \widetilde{B}\right)$, the center of $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ is given by

$$
Z\left(\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)\right)=\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right) \cap \mathcal{A}_{\varepsilon}^{1 / 2}-\operatorname{Span}\left\{M_{\varepsilon}^{\prime}(f) \mid f \in \operatorname{Ker} \Lambda_{M_{\varepsilon}^{\prime}}\right\} .
$$

Proof. Using the standard basis of a root of unity quantum torus, one easily shows that

$$
\begin{equation*}
Z\left(\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}^{\prime}\right)\right)=\mathcal{A}_{\varepsilon}^{1 / 2}-\operatorname{Span}\left\{M_{\varepsilon}^{\prime}(f) \mid f \in \operatorname{Ker} \Lambda_{M_{\varepsilon}^{\prime}}\right\} \tag{4.5}
\end{equation*}
$$

The root of unity quantum Laurent phenomenon (Theorem 3.10) implies that $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right) \subseteq \mathcal{T}_{\varepsilon}\left(M_{\varepsilon}^{\prime}\right)$. Since $\operatorname{Fract}\left(\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)\right)=\operatorname{Fract}\left(\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}^{\prime}\right)\right)$,

$$
Z\left(\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)\right)=\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right) \cap Z\left(\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}^{\prime}\right)\right)
$$

and the proposition follows from (4.5).
Remark 4.13. Using the full form of the root of unity quantum Laurent phenomenon (Theorem 3.10), one analogously proves the following stronger (but more technical) description of the center of $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ :

$$
\begin{aligned}
& Z\left(\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)\right)=\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right) \cap \\
& \quad \mathcal{A}_{\varepsilon}^{1 / 2}-\operatorname{Span}\left\{M_{\varepsilon}(f) \mid f=\left(f_{1}, \ldots, f_{N}\right) \in \operatorname{Ker} \Lambda_{M_{\varepsilon}}, f_{i} \geq 0, \forall i \notin \mathbf{e x} \sqcup \mathbf{i n v}\right\} .
\end{aligned}
$$

## 5. Strict root of unity quantum cluster algebras and Specializations

In this section we introduce the notion of strict root of unity quantum cluster algebras and show that, under certain general assumptions, they arise as specializations.

### 5.1. Construction.

Definition 5.1. Consider a root of unity quantum seed $\left(M_{\varepsilon}, \widetilde{B}\right)$, so that $\left(\Lambda_{M_{\varepsilon}}, \widetilde{B}\right)$ is $\ell$ compatible with respect to a diagonal matrix $D$. We say that this seed is strict if there exists a skew-symmetric integer matrix $\Lambda \in M_{N}(\mathbb{Z})$ such that
(1) $\bar{\Lambda}=\Lambda_{M_{\varepsilon}}$ and
(2) the pair $(\Lambda, \widetilde{B})$ is compatible with respect to the diagonal matrix $D$.

Clearly, condition (2) is stronger than requiring that $\left(\Lambda_{M_{\varepsilon}}, \widetilde{B}\right)$ be $\ell$-compatible with respect to $D$. The choice of matrix $\Lambda$ is not unique.
Proposition 5.2. If $\left(M_{\varepsilon}, \widetilde{B}\right)$ is a strict root of unity quantum seed with respect to skewsymmetric integer matrix $\Lambda \in M_{N}(\mathbb{Z})$, then $\mu_{k}\left(M_{\varepsilon}, \widetilde{B}\right)$ is also a strict root of unity quantum seed with respect to the skew-symmetric integer matrix

$$
\Lambda^{\prime}=E_{s}^{\top} \Lambda E_{s}
$$

Proof. The pair ( $E_{s}^{\top} \Lambda E_{s}, E_{s} \widetilde{B} F_{s}$ ) is the mutation of the compatible pair of matrices $(\Lambda, \widetilde{B})$. By [4, Proposition 3.4] the first pair is compatible with respect to the matrix $D$. We have

$$
\Lambda_{\mu_{k}\left(M_{\varepsilon}\right)}=\bar{E}_{s}^{\top} \Lambda_{M_{\varepsilon}} \bar{E}_{s}=\bar{E}_{s}^{\top} \bar{\Lambda} \bar{E}_{s}=\bar{\Lambda}^{\prime} .
$$

Definition 5.3. We call a root of unity quantum cluster algebra strict if one, and thus every of its seeds, is strict.

Remark 5.4. The class of strict root of unity quantum cluster algebras is a proper subset of the class of root of unity quantum cluster algebras. For example, by Remark 3.9, for $\ell=1$, a root of unity quantum cluster algebra is the same object as a classical cluster algebra. At the same time, it is easy to see that a strict root of unity quantum cluster algebra for $\ell=1$ is the same object as a classical cluster algebra with a compatible Poisson structure in the sense of Gekhtman-Shapiro-Vainshtein [22].
5.2. Specialization of quantum tori. Denote the $\ell$-th cyclotomic polynomial by

$$
\begin{equation*}
\Phi_{\ell}(t) \in \mathbb{Z}[t] . \tag{5.1}
\end{equation*}
$$

We have the isomorphism $\mathcal{A}_{q}^{1 / 2} /\left(\Phi_{\ell}\left(q^{1 / 2}\right)\right) \simeq \mathcal{A}_{\varepsilon}^{1 / 2}$ given by $q^{1 / 2} \mapsto \varepsilon^{1 / 2}$. This makes $\mathcal{T}_{q}(\Lambda) /\left(\Phi_{\ell}\left(q^{1 / 2}\right)\right)$ an $\mathcal{A}_{\varepsilon}^{1 / 2}$-algebra.
Lemma 5.5. There is an isomorphism of $\mathcal{A}_{\varepsilon}^{1 / 2}$-algebras $\mathcal{T}_{q}(\Lambda) /\left(\Phi_{\ell}\left(q^{1 / 2}\right)\right) \simeq \mathcal{T}_{\varepsilon}(\Lambda)$.
Proof of Lemma 5.5. It follows that $\mathcal{T}_{q}(\Lambda) /\left(\Phi_{\ell}\left(q^{1 / 2}\right)\right) \simeq \mathcal{T}_{\varepsilon}(\Lambda)$ since the free $\mathcal{A}_{q}^{1 / 2}$-module $\mathcal{T}_{q}(\Lambda)$ and the free $\mathcal{A}_{\varepsilon}^{1 / 2}$-module $\mathcal{T}_{\varepsilon}(\Lambda)$ both have the basis $\left\{X^{f} \mid f \in \mathbb{Z}^{N}\right\}$.

Denote the specialization map

$$
\begin{equation*}
\kappa_{\varepsilon}: \mathcal{T}_{q}(\Lambda) \rightarrow \mathcal{T}_{q}(\Lambda) /\left(\Phi_{\ell}\left(q^{1 / 2}\right)\right) \simeq \mathcal{T}_{\varepsilon}(\Lambda) . \tag{5.2}
\end{equation*}
$$

It is a homomorphism of $\mathcal{A}_{q}^{1 / 2}$-algebras, where $\mathcal{A}_{q}^{1 / 2}$ acts on $\mathcal{T}_{\varepsilon}(\Lambda)$ via the map $q \mapsto \varepsilon$.
Construction 5.6. Let $\left(M_{\varepsilon}, \widetilde{B}\right)$ be a strict root of unity quantum seed associated to a skewsymmetric integer matrix $\Lambda \in M_{N}(\mathbb{Z})$. To it we associate the unique quantum seed $\left(M_{q}, \widetilde{B}\right)$ of $\mathcal{F}_{q}:=\operatorname{Fract}\left(\mathcal{T}_{q}(\Lambda)\right)$ such that $\Lambda_{M_{q}}=\Lambda$. The compatibility of the pair $(\Lambda, \widetilde{B})$ with respect to the matrix $D$ implies that $\left(M_{q}, \widetilde{B}\right)$ is indeed a quantum seed.

The isomorphisms of quantum tori $\mathcal{T}_{q}\left(M_{q}\right) \simeq \mathcal{T}_{q}(\Lambda)$ and $\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right) \simeq \mathcal{T}_{\varepsilon}(\Lambda)$ and the specialization map (5.2) give rise to the specialization map (an $\mathcal{A}_{q}^{1 / 2}$-algebra homomorphism)

$$
\begin{equation*}
\kappa_{\varepsilon}: \mathcal{T}_{q}\left(M_{q}\right) \rightarrow \mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right) \tag{5.3}
\end{equation*}
$$

with kernel $\left(\Phi_{\ell}\left(q^{1 / 2}\right)\right)$. It is given by $\kappa_{\varepsilon}\left(M_{q}(f)\right):=M_{\varepsilon}(f)$ for $f \in \mathbb{Z}^{N}$.
The next theorem provides a general realization of a root of unity quantum cluster algebra in terms of the specialization maps (5.3) for toric frames.
Theorem 5.7. Let $\left(M_{\varepsilon}, \widetilde{B}\right)$ be a root of unity quantum toric frame associated to a skewsymmetric integer matrix $\Lambda \in M_{N}(\mathbb{Z})$ and $\left(M_{q}, \widetilde{B}\right)$ be the corresponding quantum toric frame from Construction 5.6. We have the isomorphism of $\mathcal{A}_{\varepsilon}^{1 / 2}$-algebras

$$
\begin{equation*}
\kappa_{\varepsilon}\left(\mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right)\right) \simeq \mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right) . \tag{5.4}
\end{equation*}
$$

In the special case $\varepsilon^{1 / 2}=1$ (i.e. $\ell=1$ ) the theorem provides a realization of classical cluster algebras with a compatible Poisson structure (in the sense of [22]) in terms of toric frame specializations of quantum cluster algebras, recall Remark 3.9.

Proof. Since the elements $M_{q}\left(e_{k}\right), 1 \leq k \leq N$ generate $\mathcal{T}_{q}\left(M_{q}\right)$ and $\kappa_{\varepsilon}: \mathcal{T}_{q}\left(M_{q}\right) \rightarrow \mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right)$ is a surjective ring homomorphism,

$$
\begin{equation*}
\operatorname{Fract}\left(\kappa_{\varepsilon}\left(\mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right)\right)\right) \simeq \operatorname{Fract}\left(\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right)\right) . \tag{5.5}
\end{equation*}
$$

We claim that the following hold for all quantum seeds $\left(M_{q}^{\prime}, \widetilde{B}^{\prime}\right)$ of $\mathbf{A}_{q}\left(M_{q}, \widetilde{B}\right.$,inv):
(i) $\left(\kappa_{\varepsilon} M_{q}^{\prime}, \widetilde{B}^{\prime}\right)$ is a root of unity quantum seed of $\kappa_{\varepsilon}\left(\mathbf{A}_{q}\left(M_{q}, \widetilde{B}\right.\right.$, inv $\left.)\right)$.
(ii) $\mu_{k}\left(\kappa_{\varepsilon} M_{q}^{\prime}, \widetilde{B}^{\prime}\right)=\left(\kappa_{\varepsilon}\left(M_{q}^{\prime \prime}\right), \mu_{k}\left(\widetilde{B}^{\prime}\right)\right)$ where $M_{q}^{\prime \prime}$ is the toric frame of the seed $\mu_{k}\left(M_{q}^{\prime}, \widetilde{B}^{\prime}\right)$. Property (i): $\kappa_{\varepsilon} M_{q}^{\prime}$ is a root of unity quantum toric frame of $\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right)$ because of (5.5) and the fact that $\kappa_{\varepsilon}$ is a homomorphism of $\mathcal{A}_{q}^{1 / 2}$-algebras. The compatibility of the pair $\left(\Lambda_{M_{q}}, \widetilde{B}^{\prime}\right)$ implies that the matrix of the frame $\kappa_{\varepsilon} M_{q}^{\prime}$ and the exchange matrix $\widetilde{B}^{\prime}$ are $\ell$-compatible. Property (ii) follows from the mutation formulas in Eq. (2.4) and Proposition 3.6(1), and once again the fact that fact that $\kappa_{\varepsilon}$ is an $\mathcal{A}_{q}^{1 / 2}$-algebra homomorphism.

The properties (i)-(ii), the fact that the image $\kappa_{\varepsilon}\left(\mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right)\right)$ is generated by the elements $\kappa_{\varepsilon} M_{q}^{\prime}\left(e_{j}\right)$ for quantum seeds $\left(M_{q}^{\prime}, \widetilde{B}^{\prime}\right) \sim\left(M_{q}, \widetilde{B}\right), 1 \leq j \leq N$ and by the inverses of these elements for $j \in \operatorname{inv}$ imply the isomorphism in (5.4).
5.3. Generalized specialization. For a commutative ring $\mathcal{A}$ and an ideal $\mathcal{I}$ of it, denote the factor ring $\mathcal{A}^{\prime}:=\mathcal{A} / \mathcal{I}$.

Lemma 5.8. (1) For every $\mathcal{A}$-module $V$ we have the short exact sequence of $\mathcal{A}$-modules

$$
0 \rightarrow \mathcal{I} V \rightarrow V \rightarrow \mathcal{A}^{\prime} \otimes_{\mathcal{A}} V \rightarrow 0
$$

where the third map is $v \mapsto 1 \otimes v$ for $v \in V$ and $\mathcal{A}^{\prime} \otimes_{\mathcal{A}} V$ is made into an $\mathcal{A}$-module via the surjection $\mathcal{A} \rightarrow \mathcal{A}^{\prime}$.
(2) For an $\mathcal{A}$-submodule $W \subseteq V$, the following are equivalent:
(a) the induced map $\mathcal{A}^{\prime} \otimes_{\mathcal{A}}-: \mathcal{A}^{\prime} \otimes_{\mathcal{A}} W \rightarrow \mathcal{A}^{\prime} \otimes_{\mathcal{A}} V$ is injective,
(b) $W \cap \mathcal{I} V=\mathcal{I} W$.

Proof. The first part is well known, see e.g. [20, Lemma 3.1].
(2) Consider the commutative diagram

where the horizontal maps are the ones from part (1) and the vertical ones are induced from the embedding $\theta: W \hookrightarrow V$.
(a) $\Rightarrow$ (b) Let $v_{0} \in \mathcal{I} V$ and $w \in W$ be such that $\iota_{V}\left(v_{0}\right)=\theta(w)$. Then $\theta^{\prime} \eta_{W}(w)=$ $\eta_{V} \theta(w)=\eta_{V} \iota_{V}\left(v_{0}\right)=0$. Since (a) holds, $\eta_{W}(w)=0$, and so $w \in \operatorname{Im} \iota_{W}$.
(b) $\Rightarrow$ (a) Let $w^{\prime} \in \mathcal{A}^{\prime} \otimes_{\mathcal{A}} W$ be such that $\theta^{\prime}\left(w^{\prime}\right)=0$. Choose $w \in W$ such that $w^{\prime}=\eta_{W}(w)$. Because $\eta_{V} \theta(w)=\theta^{\prime} \eta_{W}(w)=0, \theta(w) \in \operatorname{Im} \iota_{V}$. Since (b) holds, $w=\iota_{W}\left(w_{0}\right)$ for some $w_{0} \in \mathcal{I} W$, and thus $w^{\prime}=\eta_{W} \iota_{W}\left(w_{0}\right)=0$.

A special case of the second part of the lemma for principal ideal domains $\mathcal{A}$, prime ideals $\mathcal{I}$ and free modules $V$ is stated in [20, Lemma 2.1].

The $\mathcal{A}^{\prime}$-module $V / \mathcal{I} V \simeq \mathcal{A}^{\prime} \otimes_{\mathcal{A}} V$ is called the (generalized) specialization of $V$ at $\mathcal{I}$ (traditionally specialization deals with the special case when $\mathcal{I}$ is a principal idea). The canonical projection map

$$
\eta_{V}: V \rightarrow V / \mathcal{I} V \simeq \mathcal{A}^{\prime} \otimes_{\mathcal{A}} V
$$

is called the specialization map. It is a homomorphism of $\mathcal{A}$-modules. If an $\mathcal{A}$-submodule $W \subseteq V$ satisfies the equivalent conditions in Lemma 5.8(2), then

$$
W / \mathcal{I} W \simeq \eta_{V}(W) \quad \text { and } \quad \eta_{W}=\left.\eta_{V}\right|_{W}
$$

5.4. A general specialization result for quantum cluster algebras. Recall from (5.1) that $\Phi_{\ell}(t)$ denotes the $\ell$-th cyclotomic polynomial and $\mathcal{A}_{q}^{1 / 2} /\left(\Phi_{\ell}\left(q^{1 / 2}\right)\right) \simeq \mathcal{A}_{\varepsilon}^{1 / 2}$. For a quantum cluster algebra $\mathbf{A}_{q}\left(M_{q}, \widetilde{B}\right.$, inv $)$ denote the corresponding specialization map

$$
\eta_{\varepsilon}: \mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right) \rightarrow \mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right) /\left(\Phi_{\ell}\left(q^{1 / 2}\right)\right) \simeq \mathcal{A}_{\varepsilon}^{1 / 2} \otimes_{\mathcal{A}_{q}^{1 / 2}} \mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right),
$$

which is a surjective homomorphism of $\mathcal{A}_{q}^{1 / 2}$-modules.
Similarly to (3.4), for a quantum seed $\left(M_{q}^{\prime}, \widetilde{B^{\prime}}\right) \sim\left(M_{q}, \widetilde{B}\right)$ denote the subalgebra

$$
\begin{equation*}
\mathcal{T}_{q}\left(M_{q}^{\prime}\right)_{\geq}:=\mathcal{A}_{q}^{1 / 2}\left\langle M_{q}^{\prime}\left(e_{i}\right), M_{q}^{\prime}\left(e_{j}\right)^{-1} \mid i \in[1, N], j \in \mathbf{e x} \sqcup \mathbf{i n v}\right\rangle \tag{5.6}
\end{equation*}
$$

of the quantum torus $\mathcal{T}_{q}\left(M_{q}^{\prime}\right)$. It is isomorphic to the mixed (based) quantum torus/skew polynomial algebra

$$
\mathcal{A}_{\varepsilon}^{1 / 2}-\operatorname{Span}\left\{X^{f} \mid f \in \mathbb{Z}_{\geq}^{N}\right\} \quad \text { with the product } \quad X^{f} X^{g}=q^{\Lambda^{\prime}(f, g) / 2} X^{f+g}, \forall f, g \in \mathbb{Z}_{\geq}^{N}
$$

for $\mathbb{Z}_{\geq}^{N}$ as in (3.5). The specialization map $\kappa_{\varepsilon}: \mathcal{T}_{q}\left(M_{q}\right) \rightarrow \mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right) \cong \mathcal{T}_{q}\left(M_{q}\right) /\left(\Phi_{\ell}\left(q^{1 / 2}\right)\right)$ form (5.3) restricts to the specialization map

$$
\begin{equation*}
\kappa_{\varepsilon}: \mathcal{T}_{q}\left(M_{q}\right)_{\geq} \rightarrow \mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right)_{\geq} \cong \mathcal{T}_{q}\left(M_{q}\right)_{\geq} /\left(\Phi_{\ell}\left(q^{1 / 2}\right)\right) \tag{5.7}
\end{equation*}
$$

which, by abuse of notation, will be denoted by the same symbol.
The following result gives a general way of constructing root of unity quantum cluster algebras as specializations from quantum cluster algebras.

Theorem 5.9. Let $\left(M_{\varepsilon}, \Lambda, \widetilde{B}\right)$ be a root of unity quantum toric frame and $\left(M_{q}, \widetilde{B}\right)$ be the corresponding quantum toric frame from Construction 5.6. If

$$
\begin{equation*}
\mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right) \cap\left(\Phi_{\ell}\left(q^{1 / 2}\right) \mathcal{T}_{q}\left(M_{q}\right) \geq\right)=\Phi_{\ell}\left(q^{1 / 2}\right) \mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right), \tag{5.8}
\end{equation*}
$$

then the root of unity quantum cluster algebra $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \Lambda, \widetilde{B}, \mathbf{i n v}\right)$ is a specialization of the quantum cluster algebra $\mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right)$ :

$$
\mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right) /\left(\Phi_{\ell}\left(q^{1 / 2}\right)\right) \simeq \mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \Lambda, \widetilde{B}, \mathbf{i n v}\right)
$$

and the specialization map $\eta_{\varepsilon}$ is a restriction of the specialization map $\kappa_{\varepsilon}: \mathcal{T}_{q}\left(M_{q}\right) \geq \rightarrow$ $\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right) \geq$ to $\mathbf{A}_{q}\left(M_{q}, \widetilde{B}\right.$, inv $)$.

Proof. In light of Lemma 5.8(2), the assumption (5.8) implies that

$$
\mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right) /\left(\Phi_{\ell}\left(q^{1 / 2}\right)\right) \simeq \kappa_{\varepsilon}\left(\mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right)\right) \quad \text { and } \quad \eta_{\varepsilon}=\left.\kappa_{\varepsilon}\right|_{\mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right)} .
$$

Thus we have the commutative diagram


The theorem now follows from Theorem 5.7.
5.5. Specialization results for quantum cluster algebras. The following is an extension of [20, Proposition 3.5]:

Proposition 5.10. For each prime element $p \in \mathcal{A}_{q}^{1 / 2}$ and $k \in \mathbf{e x}$,

$$
\mathcal{T}_{q}\left(M_{q}\right)_{\geq} \cap\left(p \mathcal{T}_{q}\left(\mu_{k} M_{q}\right)_{\geq}\right)=\left(p \mathcal{T}_{q}\left(M_{q}\right)_{\geq}\right) \cap \mathcal{T}_{q}\left(\mu_{k} M_{q}\right)_{\geq} .
$$

Proof. We follow the line of argument of [20, Proposition 3.5] but include the proof because the original result in [20] is stated over the base ring $k\left[q^{ \pm 1 / 2}\right]$, where $k$ is a field, and for a concrete choice of $p$.

Denote by $\mathcal{T}_{q}\left(M_{q}\right)_{\geq}^{\circ}$ the subalgebra $\mathcal{T}_{q}\left(M_{q}\right) \geq$ with those generators as in (5.6) such that $i, j \neq k$. Let $X_{k}:=M_{q}\left(e_{k}\right)$ and $X_{k}^{\prime}:=\mu_{k}\left(M_{q}\right)\left(e_{k}\right) . \mathcal{T}_{q}\left(M_{q}\right) \geq$ is a free (left and right) $\mathcal{T}_{q}\left(M_{q}\right)^{\circ}$-module with basis $\left\{X_{k}^{j} \mid j \in \mathbb{Z}\right\}$ :

$$
\begin{equation*}
\mathcal{T}_{q}\left(M_{q}\right) \geq=\bigoplus_{j \in \mathbb{Z}} X_{k}^{j} \mathcal{T}_{q}\left(M_{q}\right)_{\geq}^{\circ} . \tag{5.9}
\end{equation*}
$$

For $j \in \mathbb{Z}$ denote

$$
Q^{j}=q^{j \Lambda\left(e_{k},\left[b^{k}\right]_{+}\right) / 2} M_{q}\left(\left[b^{k}\right]_{+}\right)+q^{-j \Lambda\left(e_{k},\left[b^{k}\right]_{-}\right) / 2} M_{q}\left(-\left[b^{k}\right]_{-}\right) \in \mathcal{T}_{q}\left(M_{q}\right)_{\geq}^{\circ} .
$$

We have

$$
Q^{1}=X_{k} X_{k}^{\prime} \quad \text { and } \quad Q^{j} X_{k}=X_{k} Q^{j-2}, \forall j \in \mathbb{Z}
$$

If $y \in \mathcal{T}_{q}\left(M_{q}\right) \geq \cap\left(p \mathcal{T}_{q}\left(\mu_{k} M_{q}\right) \geq\right)$, then

$$
y=\sum_{j \in \mathbb{Z}} X_{k}^{j} c_{j}=\sum_{j \in \mathbb{Z}}\left(X_{k}^{\prime}\right)^{j} d_{j},
$$

where both sums are finite and $c_{j} \in \mathcal{T}_{q}\left(M_{q}\right)_{\geq}^{\circ}, d_{j} \in p \mathcal{T}_{q}\left(M_{q}\right)_{\geq}^{\circ}$ for all $j \in \mathbb{Z}$. The free module structure (5.9) implies that

$$
\begin{array}{ll}
c_{0}=d_{0} & \\
c_{j}=Q^{-2 j-1} \ldots Q^{3} Q^{1} d_{-j} & \text { for } j<0, \\
Q^{-1} Q^{-3} \ldots Q^{-2 j+1} c_{j}=d_{-j} & \text { for } j>0 .
\end{array}
$$

Therefore $c_{j} \in p \mathcal{T}_{q}\left(M_{q}\right)_{\geq}^{\circ}$ for all $j \leq 0$. For the case $j>0$, first note that $\mathcal{A}_{q}^{1 / 2} /(p)$ is an integral domain because $p \in \mathcal{A}_{q}^{1 / 2}$ is prime. As a consequence, $\mathcal{T}_{q}\left(M_{q}\right)_{\searrow}^{\circ} / p \mathcal{T}_{q}\left(M_{q}\right)_{\searrow}^{\circ}$ is a domain since it is a subalgebra of a quantum torus with coefficients in $\mathcal{A}_{q}^{1 / 2} /(p)$. If $\tau: \mathcal{T}_{q}\left(M_{q}\right)^{\circ} \rightarrow \mathcal{T}_{q}\left(M_{q}\right)_{\geq}^{\circ} / p \mathcal{T}_{q}\left(M_{q}\right)_{\geq}^{\circ}$ denotes the canonical projection, then

$$
\tau\left(c_{j}\right) \tau\left(Q^{2 j-1}\right) \ldots \tau\left(Q^{3}\right) \tau\left(Q^{1}\right)=\tau\left(d_{-j}\right)=0
$$

Because $Q^{i} \notin p \mathcal{T}_{q}\left(M_{q}\right)_{\geq}^{\circ}$ for all $i \in \mathbb{Z}$ and $\mathcal{T}_{q}\left(M_{q}\right)_{\geq}^{\circ} / p \mathcal{T}_{q}\left(M_{q}\right)_{\geq}^{\circ}$ is a domain, $\tau\left(c_{j}\right)=0$ and thus $c_{j} \in p \mathcal{T}_{q}\left(M_{q}\right)_{\geq}^{\circ}$ for $j>0$. Hence, $y \in p \mathcal{T}_{q}\left(M_{q}\right) \geq$.

Theorem 5.11. Let $\left(M_{\varepsilon}, \Lambda, \widetilde{B}\right)$ be a root of unity quantum toric frame and $\left(M_{q}, \widetilde{B}\right)$ be the corresponding quantum toric frame from Construction 5.6. If

$$
\mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right)=\mathbf{U}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right),
$$

then the root of unity quantum cluster algebra $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \Lambda, \widetilde{B}, \mathbf{i n v}\right)$ is a specialization of the quantum cluster algebra $\mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right)$ :

$$
\mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right) /\left(\Phi_{\ell}\left(q^{1 / 2}\right)\right) \simeq \mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \Lambda, \widetilde{B}, \mathbf{i n v}\right)
$$

and the specialization map $\eta_{\varepsilon}$ is a restriction of the specialization map $\kappa_{\varepsilon}: \mathcal{T}_{q}\left(M_{q}\right) \geq \rightarrow$ $\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}\right) \geq$ from (5.7) to $\mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right)$.

Proof. Applying Proposition 5.10, one proves that for all quantum seeds $\left(M_{q}^{\prime}, \widetilde{B}^{\prime}\right) \sim\left(M_{q}, \widetilde{B}\right)$,

$$
\begin{aligned}
\mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right) \cap\left(\Phi_{\ell}\left(q^{1 / 2}\right) \mathcal{T}_{q}\left(M_{q}\right)_{\geq}\right) & =\mathbf{U}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right) \cap\left(\Phi_{\ell}\left(q^{1 / 2}\right) \mathcal{T}_{q}\left(M_{q}\right)_{\geq}\right) \\
& \subseteq \Phi_{\ell}\left(q^{1 / 2}\right) \mathcal{T}_{q}\left(M_{q}^{\prime}\right) \geq
\end{aligned}
$$

by induction on the distance from $\left(M_{q}, \widetilde{B}\right)$ to $\left(M_{q}^{\prime}, \widetilde{B}^{\prime}\right)$ in the exchange graph. Hence

$$
\mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right) \cap\left(\Phi_{\ell}\left(q^{1 / 2}\right) \mathcal{T}_{q}\left(M_{q}\right)_{\geq}\right) \subseteq \Phi_{\ell}\left(q^{1 / 2}\right) \mathbf{U}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right)=\Phi_{\ell}\left(q^{1 / 2}\right) \mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right)
$$

and clearly $\mathbf{A}_{q}\left(M_{q}, \widetilde{B}, \mathbf{i n v}\right) \cap\left(\Phi_{\ell}\left(q^{1 / 2}\right) \mathcal{T}_{q}\left(M_{q}\right) \geq\right) \supseteq \Phi_{\ell}\left(q^{1 / 2}\right) \mathbf{A}_{q}\left(M_{q}, \widetilde{B}\right.$, inv $)$. This verifies the condition (5.8) and the theorem now follows from Theorem 5.9.
5.6. An example: quantized Weyl algebras at roots of unity. Let $Q=\left(a_{i j}\right) \in M_{n}(\mathbb{Z})$ be a skew-symmetric integer matrix and $\varepsilon^{1 / 2} \in \mathbb{C}$ be a primitive $\ell$-th root of unity for $\ell>1$. Denote by $A_{n, \varepsilon, \mathbb{C}}^{Q}$ the quantized Weyl algebra at the root of unity $\varepsilon$, which is a $\mathbb{C}$-algebra generated by $x_{i}, y_{i}$ for $i \in[1, n]$ with relations

$$
\begin{aligned}
& y_{i} y_{j}=\varepsilon^{a_{i j}} y_{j} y_{i}, \quad x_{i} x_{j}=\varepsilon^{1+a_{i j}} x_{j} x_{i} \text { for } i<j, \\
& x_{i} y_{j}=\varepsilon^{-a_{i j}} y_{j} x_{i} \text { for } i<j, \quad x_{i} y_{j}=\varepsilon^{1-a_{i j}} y_{j} x_{i} \text { for } i>j, \\
& x_{j} y_{j}=1+\varepsilon y_{j} x_{j}+(\varepsilon-1) \sum_{r=1}^{j-1} y_{r} x_{r} .
\end{aligned}
$$

Note that $\left\{x_{i},(\varepsilon-1) y_{i} \mid 1 \leq i \leq n\right\}$ is another set of generators for this algebra. Denote by $A_{n, \varepsilon, \mathbb{Z}}^{Q}$ the $\mathcal{A}_{\varepsilon}^{1 / 2}$-subalgebra generated by $x_{i},(\varepsilon-1) y_{i}$. It is an $\mathcal{A}_{\varepsilon}^{1 / 2}$-form of $A_{n, \varepsilon, \mathbb{C}}^{Q}$. The algebra $A_{n, \varepsilon, \mathbb{Z}}^{Q}$ is a specialization of the $\mathcal{A}_{q}^{1 / 2}$-algebra $A_{n, q, \mathbb{Z}}^{Q}$ with generators and relations as in [24, Eq. (4.9)]:

$$
A_{n, \varepsilon, \mathbb{Z}}^{Q} \cong A_{n, q, \mathbb{Z}}^{Q} / \Phi_{\ell}\left(q^{1 / 2}\right)
$$

This easily follows by using bases for both algebras.
By [24, Example 4.10] $A_{n, q, \mathbb{Z}}^{Q}$ has a quantum cluster algebra structure and by [24, Theorem 4.8] this quantum cluster algebra equals the corresponding upper quantum cluster algebra. Proposition 5.10 implies that $A_{n, \varepsilon, \mathbb{Z}}^{Q}$ has a strict root of unity quantum cluster algebra structure. The root of unity quantum toric frame for its initial seed is given by

$$
M_{\varepsilon}\left(e_{i}\right):=x_{i}, \quad M_{\varepsilon}\left(e_{i+n}\right):=\left[x_{i}, y_{i}\right]=1+(\varepsilon-1) \sum_{r=1}^{i} x_{r} y_{r} \quad \text { for } \quad 1 \leq i \leq n
$$

and the corresponding matrix is

$$
\Lambda=\left[\begin{array}{cc}
Q^{\prime} & -R \\
R & 0_{n \times n}
\end{array}\right]
$$

whose blocks are the $n \times n$ integer matrices

$$
\left(Q^{\prime}\right)_{i j}=\left\{\begin{array}{ll}
a_{i j}+1 & \text { if } i<j \\
-a_{j i}-1 & \text { if } i>j \\
0 & \text { if } i=j
\end{array} \quad(R)_{i j}= \begin{cases}1 & \text { if } i<j \\
a_{j i} & \text { if } i>j \\
0 & \text { if } i=j\end{cases}\right.
$$

The set of exchangeable indices is $\mathbf{e x}=[1, n]$ and the set of inverted frozen variable is empty inv $=\varnothing$. The exchange matrix of the seed is

$$
\widetilde{B}=\left[\begin{array}{c}
0_{n \times n} \\
S
\end{array}\right]
$$

where the entries of $S \in M_{n}(\mathbb{Z})$ are $(S)_{i, n+1-i}=1,(S)_{i, n-i}=-1,(S)_{i j}=0$ otherwise.

## 6. Discriminants of root of unity quantum cluster algebras

In this section we prove a general result for the computation of discriminants of root of unity quantum cluster algebras.
6.1. Background on discriminants. For an algebraic number field $K$, consider its trace function $\operatorname{tr}=\operatorname{tr}_{K / \mathbb{Q}}: K \rightarrow \mathbb{Q}$ obtained from the composition $K \hookrightarrow M_{N}(\mathbb{Q}) \xrightarrow{\mathrm{Tr}} \mathbb{Q}$, where the first embedding is obtained from the $K$-action on $K \simeq \mathbb{Q}^{N}$ (for some positive integer $N)$ and the second map is the trace map on matrices. The discriminant of $K$ is defined by

$$
\Delta_{K}:=\operatorname{det}\left(\operatorname{tr}\left(y_{i} y_{j}\right)\right)_{i, j=1}^{N},
$$

where $\left\{y_{1}, y_{2}, \ldots, y_{N}\right\}$ is a $\mathbb{Z}$-basis of the ring of integers $O_{K}$ of $K$. The discriminant does not depend on the choice of basis. More generally, we consider algebras with trace:

Definition 6.1. An algebra with trace is a ring $R$ with a central subring $C$ and a $C$-linear map tr : $R \rightarrow C$ such that

$$
\operatorname{tr}(x y)=\operatorname{tr}(y x), \quad \forall x, y \in R .
$$

Such a ring $R$ is naturally a $C$-algebra.
Example 6.2. Consider a ring $R$ which is free and of finite rank $N$ over a central subring $C \subseteq Z(R)$. Choosing a $C$-basis of $R$ gives rise to a $C$-module isomorphism $R \simeq C^{N}$, and the left action of $R$ on itself gives rise to an algebra homomorphism $R \rightarrow M_{N}(C)$. The regular trace of $R$ is defined as the composition

$$
\operatorname{tr}_{\mathrm{reg}}: R \rightarrow M_{N}(C) \xrightarrow{\operatorname{Tr}} C \subseteq R,
$$

where the second maps is the trace map on matrices. The trace map $\operatorname{tr}_{\mathrm{reg}}$ is independent of the choice of $C$-basis used to construct the homomorphism $R \rightarrow M_{N}(C)$.

For a commutative ring $C$, denote by $C^{\times}$its group of units (i.e., invertible elements under the product operation). Two elements $c_{1}, c_{2} \in C$ are called associates (denoted $c_{1}={ }_{C \times} c_{2}$ ) if $c_{1}=u c_{2}$ for some $u \in C^{\times}$.
Definition 6.3. Assume that $R$ is an algebra with trace $\operatorname{tr}: R \rightarrow C$ such that $R$ is a free and of finite rank $N$ over the central subring $C \subseteq Z(R)$. The discriminant of $R$ over $C$ is defined by

$$
\begin{equation*}
d(R / C):=_{C \times} \operatorname{det}\left(\operatorname{tr}\left(y_{i} y_{j}\right)\right)_{i, j=1}^{N}, \tag{6.1}
\end{equation*}
$$

where $\left\{y_{1}, y_{2}, \ldots, y_{N}\right\}$ is a $C$-basis of $R$. For different choices of $C$-bases of $R$, the right hand sides of (6.1) are associates of each other.
6.2. Nerves and the algebras $\mathbf{A}_{\varepsilon}(\Theta$, inv $)$ and $\mathbf{C}_{\varepsilon}(\Theta$, inv $)$. Let $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}\right.$, inv $)$ be a quantum cluster algebra with exchange graph $E_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}\right)$.

For a collection of seeds $\Theta$ in $E_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}\right)$, let
(1) $\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v})$ be $\mathcal{A}_{\varepsilon}^{1 / 2}$-subalgebra of $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ generated by $M_{\varepsilon}^{\prime}\left(e_{j}\right)$ for $j \in[1, N]$ and $M_{\varepsilon}^{\prime}\left(e_{i}\right)^{-1}$ for $i \in \operatorname{inv}$, for all $\left(M_{\varepsilon}^{\prime}, \widetilde{B}^{\prime}\right) \in \Theta$, and
(2) $\mathbf{C}_{\varepsilon}(\Theta$, inv $)$ be $\mathcal{A}_{\varepsilon}^{1 / 2}$-subalgebra of $\mathbf{C}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}\right.$, inv $)$ generated by $M_{\varepsilon}^{\prime}\left(e_{j}\right)^{\ell}$ for $j \in[1, N]$ and $M_{\varepsilon}^{\prime}\left(e_{i}\right)^{-\ell}$ for $i \in \operatorname{inv}$, for all $\left(M_{\varepsilon}^{\prime}, \widetilde{B}^{\prime}\right) \in \Theta$.
Thus $\mathbf{C}_{\varepsilon}(\Theta, \mathbf{i n v})$ is in the center of $\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v})$.
Definition 6.4. A subset of seeds $\Theta$ that satisfies the following conditions is called a nerve:
(1) The subgraph in $E_{\varepsilon}\left(M_{\varepsilon}, B\right)$ induced by $\Theta$ is connected.
(2) For each mutable direction $k \in \mathbf{e x}$, there are at least two seeds in $\Theta$ mutation equivalent by $\mu_{k}$.

The concept of nerves was introduced in [16] for a practical way of specifying a quasihomomorphism of a cluster algebra. A basic example of a nerve would be a star neighborhood in $E_{\varepsilon}\left(M_{\varepsilon}, B\right)$ of any particular seed.
6.3. The discriminant of $\mathbf{A}_{\varepsilon}(\Theta$, inv $)$ over $\mathbf{C}_{\varepsilon}(\Theta, \mathbf{i n v})$. For the proof of the main theorem on discriminants we will need the following lemma. Its proof was communicated to us by Greg Muller.

## Lemma 6.5. If

$$
\begin{equation*}
n \prod_{i=1}^{N} x_{i}^{a_{i}} \in \mathbf{A}(\widetilde{\mathbf{x}}, \widetilde{B}, \mathbf{i n v}) \tag{6.2}
\end{equation*}
$$

for some $a_{i}, n \in \mathbb{Z}, n \neq 0$, then $a_{i} \geq 0$ for $i \notin \mathbf{i n v}$.
Proof. It is sufficient to prove the statement in the case inv $=\varnothing$ because (6.2) implies that $n \prod_{i=1}^{N} x_{i}^{a_{i}} \prod_{i \in \operatorname{inv}} x_{i}^{c_{i}} \in \mathbf{A}(\widetilde{\mathbf{x}}, \widetilde{B}, \varnothing)$ for some $c_{i} \in \mathbb{N}$. For the rest of the proof we assume that inv $=\varnothing$.

If $i \in \mathbf{e x}$, then $a_{i} \geq 0$ because, if $a_{i}<0$, then expressing the Laurent monomial in terms of the cluster variables of the seed $\mu_{i}(\widetilde{\mathbf{x}}, \widetilde{B})$ would contradict the Laurent phenomenon. If $i \notin \mathbf{e x}$, the statement follows from [14, Proposition 3.6].
Theorem 6.6. Consider a root of unity quantum cluster algebra $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \mathbf{i n v}\right)$ satisfying the condition (Coprime), where $\varepsilon^{1 / 2}$ is a primitive $\ell$-th root of unity. Let $\Theta$ be collection of seeds which is a nerve.
(1) If $\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v})$ is a free $\mathbf{C}_{\varepsilon}(\Theta, \mathbf{i n v})$-module, then $\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v})$ is a finite rank $\mathbf{C}_{\varepsilon}(\Theta$, inv $)$ module of rank $\ell^{N}$ and its discriminant with respect to the regular trace function is given as a product of noninverted frozen variables raised to the $\ell$-th power,

$$
d\left(\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v}) / \mathbf{C}_{\varepsilon}(\Theta, \mathbf{i n v})\right)=\mathbf{C}_{\varepsilon}(\Theta, \mathbf{i n v})^{\times} \ell^{\left(N \ell^{N}\right)} \prod_{i \in[1, N] \backslash(\mathbf{e x} \sqcup \mathbf{i n v})} M_{\varepsilon}\left(e_{i}\right)^{\ell a_{i}} \quad \text { for some } a_{i} \in \mathbb{N} .
$$

(2) If $\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v})$ is a free $\mathbf{C}(\Theta, \mathbf{i n v})$-module, then $\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v})$ is a finite rank $\mathbf{C}(\Theta, \mathbf{i n v})$ module of rank $\ell^{N} \varphi(\ell)$ and its discriminant with respect to the regular trace function is given by

$$
\left.d\left(\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v}) / \mathbf{C}(\Theta, \mathbf{i n v})\right)=\mathbf{c}(\Theta, \mathbf{i n v})^{\times}\left(\frac{\ell^{(N+1) \varphi(\ell)}}{\prod_{p \mid \ell} p^{\varphi(\ell) /(p-1)}}\right)_{i \in[1, N] \backslash(\mathbf{e x} \sqcup \mathbf{i n v})}^{\ell^{N}} \prod_{i} M_{i}\right)^{\ell c_{i}}
$$

for some $c_{i} \in \mathbb{N}$.
Proof. Throughout the proof all discriminants are computed with respect to the regular traces of the algebras that are involved.
(1) For a root of unity quantum frame $M_{\varepsilon}^{\prime}$ denote the skew polynomial subalgebra of $\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}^{\prime}\right)$

$$
\mathcal{S}_{\varepsilon}\left(M_{\varepsilon}^{\prime}\right):=\mathcal{A}_{\varepsilon}^{1 / 2}\left\langle M_{\varepsilon}^{\prime}\left(e_{i}\right), 1 \leq i \leq N\right\rangle \simeq \mathcal{A}_{\varepsilon}^{1 / 2}\left\langle X_{1}, \ldots, X_{N}\right\rangle /\left(X_{i} X_{j}-\varepsilon^{\lambda_{i j}^{\prime}} X_{j} X_{i}\right),
$$

where $\lambda_{i j}^{\prime}:=\Lambda_{M_{\varepsilon}^{\prime}}\left(e_{i}, e_{j}\right)$. By [7, Proposition 2.8], the discriminant of $\mathcal{S}_{\varepsilon}\left(M_{\varepsilon}^{\prime}\right)$ over the central subalgebra $\mathcal{A}_{\varepsilon}^{1 / 2}\left[M_{\varepsilon}^{\prime}\left(e_{i}\right)^{\ell}\right]_{i=1}^{N}$ is given by

$$
d\left(\mathcal{S}_{\varepsilon}\left(M_{\varepsilon}^{\prime}\right) / \mathcal{A}_{\varepsilon}^{1 / 2}\left[M_{\varepsilon}^{\prime}\left(e_{i}\right)^{\ell}\right]_{i=1}^{N}\right)=_{\mathcal{A}_{\varepsilon}^{1 / 2} \times \ell^{N \ell^{N}}} \prod_{i \in[1, N]}\left(M_{\varepsilon}^{\prime}\left(e_{i}\right)^{\ell^{N}(\ell-1)}\right) .
$$

Therefore the discriminant of its localization

$$
\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}^{\prime}\right) \simeq \mathcal{S}_{\varepsilon}\left(M_{\varepsilon}^{\prime}\right)\left[M_{\varepsilon}^{\prime}\left(e_{i}\right)^{-\ell}\right]_{i=1}^{N}
$$

is given by

$$
d\left(\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}^{\prime}\right) / \mathcal{A}_{\varepsilon}^{1 / 2}\left[M_{\varepsilon}^{\prime}\left(e_{i}\right)^{ \pm \ell}\right]_{i=1}^{N}\right)={ }_{\left(\mathcal{A}_{\varepsilon}^{1 / 2}\left[M_{\varepsilon}^{\prime}\left(e_{i}\right)^{ \pm \ell}\right]_{i=1}^{N}\right.} \times \ell^{N \ell^{N}}
$$

For the rest of the proof assume that $\left(M_{\varepsilon}^{\prime}, \widetilde{B}^{\prime}\right) \in \Theta$. Applying Theorem 4.6 (using the assumption that $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}\right.$, inv $)$ satisfies the condition (Coprime)) and the Laurent phenomenon, we obtain that

$$
\mathbf{C}_{\varepsilon}(\Theta, \mathbf{i n v})\left[M_{\varepsilon}^{\prime}\left(e_{i}\right)^{-\ell}\right]_{i=1}^{N} \simeq \mathcal{A}_{\varepsilon}^{1 / 2}\left[M_{\varepsilon}^{\prime}\left(e_{i}\right)^{ \pm \ell}\right]_{i=1}^{N} .
$$

The root of unity quantum Laurent phenomenon (Theorem 3.10) implies

$$
\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v})\left[M_{\varepsilon}^{\prime}\left(e_{i}\right)^{-\ell}\right]_{i=1}^{N} \simeq \mathcal{T}_{\varepsilon}\left(M_{\varepsilon}^{\prime}\right)
$$

Therefore, the rank of $\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v})$ as an $\mathbf{C}_{\varepsilon}(\Theta$, inv $)$-module equals the rank of $\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}^{\prime}\right)$ as an $\mathcal{A}_{\varepsilon}^{1 / 2}\left[M_{\varepsilon}^{\prime}\left(e_{i}\right)^{ \pm \ell}\right]_{i=1}^{N}$-module. Since the latter rank equals $\ell^{N}, \mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v})$ is a finite rank $\mathbf{C}_{\varepsilon}(\Theta, \mathbf{i n v})$-module of rank $\ell^{N}$. Furthermore,

$$
\begin{equation*}
d\left(\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v})\left[M_{\varepsilon}^{\prime}\left(e_{i}\right)^{-\ell}\right]_{i=1}^{N} / \mathbf{C}_{\varepsilon}(\Theta, \mathbf{i n v})\left[M_{\varepsilon}^{\prime}\left(e_{i}\right)^{-\ell}\right]_{i=1}^{N}\right)=\mathcal{T}_{\varepsilon}\left(M_{\varepsilon}^{\prime}\right) \times \ell^{N \ell^{N}} . \tag{6.3}
\end{equation*}
$$

Theorem 4.6 implies that

$$
\begin{equation*}
\mathbf{C}_{\varepsilon}(\Theta, \text { inv }) \cap \mathcal{T}_{\varepsilon}\left(M_{\varepsilon}^{\prime}\right)^{\times} \subseteq\left\{\left(\mathcal{A}_{\varepsilon}^{1 / 2}\right)^{\times} M_{\varepsilon}^{\prime}\left(e_{1}\right)^{\ell a_{1}} \ldots M_{\varepsilon}^{\prime}\left(e_{N}\right)^{\ell a_{N}} \mid a_{i} \in \mathbb{Z}\right\} \tag{6.4}
\end{equation*}
$$

Combining (6.3) and (6.4) gives that for all seeds $\left(M_{\varepsilon}^{\prime}, \widetilde{B}^{\prime}\right) \in \Theta$,

$$
\begin{equation*}
d\left(\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v}) / \mathbf{C}_{\varepsilon}(\Theta, \mathbf{i n v})\right)=\mathbf{c}_{\varepsilon}(\Theta, \mathbf{i n v})^{\times} \ell^{N \ell^{N}} \prod_{i \in[1, N]}\left(M_{\varepsilon}^{\prime}\left(e_{i}\right)^{\ell}\right)^{a_{i}} \tag{6.5}
\end{equation*}
$$

for some integers $a_{i}$ (depending on each seed). We will assume that $a_{i}=0$ for $i \in \operatorname{inv}$ since $M_{\varepsilon}\left(e_{i}\right)^{\ell} \in \mathbf{C}_{\varepsilon}(\Theta, \mathbf{i n v})^{\times}$for $i \in \mathbf{i n v}$. Theorem 4.6 and Lemma 6.5 imply that $a_{i} \geq 0$ for $i \notin$ inv.

Fix $k \in$ ex. Since $\Theta$ is a nerve, there exists $\left(M_{\varepsilon}^{\prime}, \widetilde{B}^{\prime}\right) \in \Theta$ such that $\mu_{k}\left(M_{\varepsilon}^{\prime}, \widetilde{B^{\prime}}\right) \in \Theta$. Applying (6.5) to the two seeds gives

d\left(\mathbf{A}_{\varepsilon}(\Theta, \mathbf{i n v}) / \mathbf{C}_{\varepsilon}(\Theta, \mathbf{i n v})\right) & =\mathbf{C}_{\varepsilon}(\Theta, \mathbf{i n v})^{\times} \times \ell^{N \ell^{N}}\left(M_{\varepsilon}^{\prime}\left(e_{k}\right)^{\ell}\right)^{a_{k}} \prod_{i \in[1, N] \backslash(\mathbf{i n v} \sqcup\{k\})}\left(M_{\varepsilon}^{\prime}\left(e_{i}\right)^{\ell}\right)^{a_{i}} \\
& =\mathbf{c}_{\varepsilon}(\Theta, \mathbf{i n v})^{\times} \times \ell^{N \ell^{N}}\left(\mu_{k} M_{\varepsilon}^{\prime}\left(e_{k}\right)^{\ell}\right)^{c_{k}} \prod_{i \in[1, N] \backslash(\mathbf{i n v} \sqcup\{k\})}\left(M_{\varepsilon}^{\prime}\left(e_{i}\right)^{\ell}\right)^{c_{i}}
\end{aligned}
$$

for some $a_{i}, c_{i} \in \mathbb{Z}, i \in[1, N] \backslash$ inv. By Proposition 4.4,

$$
\mu_{k} M_{\varepsilon}^{\prime}\left(e_{k}\right)^{\ell}=M_{\varepsilon}^{\prime}\left(-e_{k}+\left[b^{k}\right]_{+}\right)^{\ell}+M_{\varepsilon}^{\prime}\left(-e_{k}-\left[b^{k}\right]_{-}\right)^{\ell},
$$

which is not a monomial of the $M_{\varepsilon}^{\prime}\left(e_{i}\right)$ 's for $i \in[1, N] \backslash(\mathbf{i n v} \sqcup\{k\})$. Hense,

$$
\begin{aligned}
a_{k} & =0=c_{k}, \\
a_{i} & =c_{i} \text { for } i \neq k .
\end{aligned}
$$

Because of the connectedness assumption in Definition 6.4(1), for all seeds ( $\left.M_{\varepsilon}^{\prime}, \widetilde{B}^{\prime}\right) \in \Theta$ and $k \in \mathbf{e x} \sqcup \mathbf{i n v}, a_{k}=0$ in (6.5).
(2) For every root of unity quantum frame $M_{\varepsilon}^{\prime}, \mathcal{S}_{\varepsilon}\left(M_{\varepsilon}^{\prime}\right)$ is a free $\mathbb{Z}\left[M_{\varepsilon}^{\prime}\left(e_{i}\right)^{\ell}\right]_{i=1}^{N}$-module of rank $\ell^{N} \varphi(\ell)$. The discriminant of the cyclotomic field extension $\mathbb{Q}\left(\varepsilon^{1 / 2}\right)$ of $\mathbb{Q}$ equals

$$
\frac{(-1)^{\varphi(\ell) / 2} \ell^{\varphi(\ell)}}{\prod_{p \mid \ell} p^{p^{(\ell) /(p-1)}}}
$$

From this one easily deduces that

$$
d\left(\mathcal{S}_{\varepsilon}\left(M_{\varepsilon}^{\prime}\right) / \mathbb{Z}\left[M_{\varepsilon}^{\prime}\left(e_{i}\right)^{\ell}\right]_{i=1}^{N}\right)=\mathbb{Z}^{\times}\left(\frac{\ell^{(N+1) \varphi(\ell)}}{\prod_{p \mid \ell} p^{\varphi(\ell) /(p-1)}}\right)^{\ell^{N}} \prod_{i \in[1, N]}\left(M_{\varepsilon}^{\prime}\left(e_{i}\right)^{\ell^{N}(\ell-1) \varphi(\ell)}\right) .
$$

Using this formula, the proof of part (2) is carried out using exactly the same arguments as part (1).

Remark 6.7. Since it is unknown whether $\mathbf{C}_{\varepsilon}(\Theta$, inv $)$ is a free $\mathbf{C}(\Theta$, inv $)$, part (2) of the theorem is not an consequence of part (1) and the formula for the discriminants of cyclotomic field extensions.
6.4. An example: discriminants of quantized Weyl algebras at roots of unity. By the construction in Sect. 5.6,

$$
A_{n, \varepsilon, \mathbb{Z}}^{Q} \cong \mathbf{A}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \varnothing\right)
$$

for the toric frame $M_{\varepsilon}$ and exchange matrix $\widetilde{B}$ specified there. The underlying cluster algebra is of finite type $A_{1} \sqcup \ldots \sqcup A_{1}$. Let $\varepsilon^{1 / 2}$ be a primitive $\ell$-th root of unity for an odd integer $\ell>1, \mathcal{A}_{\varepsilon}^{1 / 2}=\mathcal{A}_{\varepsilon}$. Denote

$$
C_{n, \varepsilon, \mathbb{Z}}^{Q}:=\mathcal{A}_{\varepsilon}\left[x_{i}^{\ell},\left((\varepsilon-1) y_{i}\right)^{\ell}, 1 \leq k \leq n\right] .
$$

It is well known and easy to verify that $C_{n, \varepsilon, \mathbb{Z}}^{Q}$ is in the center of $A_{n, \varepsilon, \mathbb{Z}}^{Q}$. We apply Theorem 6.6 for $\Theta$ equal to the set of all seeds of the root of unity quantum cluster algebra. It is easy to see that it has $2^{n}$ seeds with cluster variables

$$
\left(t_{1}, \ldots, t_{n},-z_{1}, \ldots,(-1)^{i} z_{i}, \ldots,(-1)^{n} z_{n}\right) \quad \text { where } t_{i}=(-1)^{i} \varepsilon^{1 / 2} x_{i} \text { or } t_{i}=(\varepsilon-1) y_{i}
$$

This implies that $\mathbf{C}_{\varepsilon}\left(M_{\varepsilon}, \widetilde{B}, \varnothing\right)=C_{n, \varepsilon, \mathbb{Z}}^{Q}$. The algebra $A_{n, \varepsilon, \mathbb{Z}}^{Q}$ is a free $C_{n, \varepsilon, \mathbb{Z}}^{Q}$-module with basis

$$
\left\{x_{1}^{j_{1}} \ldots x_{n}^{j_{n}} y_{1}^{m_{1}} \ldots y_{n}^{m_{n}} \mid j_{1}, \ldots, j_{n}, m_{1}, \ldots, m_{n} \in[0, \ell-1]\right\} .
$$

Applying Theorem 6.6 gives that

$$
\begin{equation*}
d\left(A_{n, \varepsilon, \mathbb{Z}}^{Q} / C_{n, \varepsilon, \mathbb{Z}}^{Q}\right)=_{\mathcal{A}_{\varepsilon}} \times \ell^{2 n \ell^{2 n}} z_{1}^{\ell a_{1}} \ldots \ell_{n}^{\ell a_{n}} \tag{6.6}
\end{equation*}
$$

for some $a_{k} \in \mathbb{N}$ (here and below discriminants are computed with respect to the regular trace). To determine the integers $a_{k}$, consider the filtration of $A_{n, \varepsilon, \mathbb{Z}}^{Q}$ given by $\operatorname{deg} x_{k}=$ $\operatorname{deg} y_{k}=k$ for $k \in[1, n]$. The associated graded is isomorphic to a skew-polynomial algebra with generators given by the images of $x_{k},(\varepsilon-1) y_{k}$ for $k \in[1, n]$, which will be denoted by $\overline{x_{k}}, \overline{(\varepsilon-1) y_{k}}$. The discriminants of skew-polynomial algebras are given by [7, Proposition 2.8]:

$$
d\left(\operatorname{gr} A_{n, \varepsilon, \mathbb{Z}}^{Q} / \operatorname{gr} C_{n, \varepsilon, \mathbb{Z}}^{Q}\right)=\mathcal{A}_{\varepsilon} \times \ell^{2 n \ell^{2 n}}\left(\overline{x_{1}} \overline{(\varepsilon-1) y_{1}}\right)^{(\ell-1) \ell^{n}} \ldots\left(\overline{x_{n}} \overline{(\varepsilon-1) y_{n}}\right)^{(\ell-1) \ell^{n}} .
$$

Applying [7, Proposition 4.10] to (6.6) gives that $a_{1}=\ldots=a_{n}=(\ell-1) \ell^{n-1}$, which proves the following:
Proposition 6.8. For each root of unity $\varepsilon^{1 / 2}$ of odd order $\ell$, the discriminant of the quantized Weyl algebra $A_{n, \varepsilon, \mathbb{Z}}^{Q}$ over its central subalgebra $C_{n, \varepsilon, \mathbb{Z}}^{Q}$ with respect to the regular trace is given by

$$
d\left(A_{n, \varepsilon, \mathbb{Z}}^{Q} / C_{n, \varepsilon, \mathbb{Z}}^{Q}\right)={ }_{\mathcal{A}_{\varepsilon}} \times \ell^{2 n \ell^{2 n}} z_{1}^{(\ell-1) \ell^{n}} \ldots z_{n}^{(\ell-1) \ell^{n}} .
$$

In the case of $n=1$ this fact was first proved in [8, Theorem 0.1] and for general values of $n$ in [29, Theorem B(ii)].

## 7. Quantum groups

In this section we gather material about quantized universal enveloping algebras of symmetrizable Kac-Moody algebras, their integral forms and specializations to roots of unity.
7.1. Quantized universal enveloping algebras. We will follow the notation of Kashiwara for quantized universal enveloping algebras of symmetrizable Kac-Moody algebras, $[26]$. Let $I:=[1, r]$ serve as an index set and $\left(A, P, \Pi, P^{\vee}, \Pi^{\vee}\right)$ be a Cartan datum comprised of the following:
(i) A symmetrizable, generalized Cartan matrix $A=\left(a_{i j}\right)_{i, j \in I}$. In particular, $a_{i i}=2$ for $i \in I, a_{i j} \in \mathbb{Z}_{\leq 0}$ for $i \neq j$, and there exists a diagonal matrix $D=\left(d_{i}\right)_{i \in I}$ consisting of positive, relatively prime integers $d_{i}$ such that $D A$ is symmetric.
(ii) A free abelian group $P$ (weight lattice).
(iii) A linearly independent subset $\Pi=\left\{\alpha_{i} \mid i \in I\right\} \subset P$ (set of simple roots).
(iv) The dual group $P^{\vee}=\operatorname{Hom}_{\mathbb{Z}}(P, \mathbb{Z})$ (coweight lattice).
(v) Two linearly independent subsets $\Pi^{\vee}=\left\{h_{i} \mid i \in I\right\} \subset P^{\vee}$ (set of simple coroots), such that $\left\langle h_{i}, \alpha_{j}\right\rangle=a_{i j}$ for $i, j \in I$, and $\left\{\varpi_{i} \mid i \in I\right\} \subset P$ (set of fundamental weights), such that $\left\langle h_{i}, \varpi_{j}\right\rangle=\delta_{i j}$ for $i, j \in I$.
Let $P_{+}:=\left\{\gamma \in P \mid\left\langle h_{i}, \gamma\right\rangle \in \mathbb{Z}_{\geq 0}\right\}$. Denote the root lattice $Q:=\bigoplus_{i \in I} \mathbb{Z} \alpha_{i}$ and set $Q_{+}:=\bigoplus_{i \in I} \mathbb{Z}_{\geq 0} \alpha_{i}$. Set $\mathfrak{h}:=\mathbb{Q} \otimes_{\mathbb{Z}} P^{\vee}$. There is a $\mathbb{Q}$-valued nondegenerate, symmetric bilinear form $(\cdot, \cdot)$ on $\mathfrak{h}^{*}=\mathbb{Q} \otimes_{\mathbb{Z}} P$ that satisfies

$$
\left\langle h_{i}, \mu\right\rangle=\frac{2\left(\alpha_{i}, \mu\right)}{\left(\alpha_{i}, \alpha_{i}\right)} \quad \text { and } \quad\left(\alpha_{i}, \alpha_{i}\right)=2 d_{i} \quad \text { for all } i \in I, \mu \in \mathfrak{h}^{*}
$$

Note that the existence of such a bilinear form is equivalent to the symmetrizability of the generalized Cartan matrix $A$. Denote $\|\mu\|:=(\mu, \mu)$ for $\mu \in \mathfrak{h}^{*}$.

Let $\mathfrak{g}$ be the symmetrizable Kac-Moody algebra over $\mathbb{Q}$ associated to this Cartan datum. It is the Lie algebra generated by $\mathfrak{h}, e_{i}$, and $f_{i}$ for $i \in I$ with Serre relations for $h \in \mathfrak{h}$ and $i, j \in I$,
$\mathfrak{h}$ is an abelian Lie subalgebra,

$$
\begin{aligned}
& {\left[h, e_{i}\right]=\left\langle h, \alpha_{i}\right\rangle e_{i}, \quad\left[h, f_{i}\right]=-\left\langle h, \alpha_{i}\right\rangle f_{i}, \quad\left[e_{i}, f_{j}\right]=\delta_{i j} h_{i}} \\
& \left(\operatorname{ad} e_{i}\right)^{1-a_{i j}}\left(e_{j}\right)=0, \quad\left(\operatorname{ad} f_{i}\right)^{1-a_{i j}}\left(f_{j}\right)=0
\end{aligned}
$$

Let $W$ be the Weyl group of $\mathfrak{g}$, acting on $\left(\mathfrak{h}^{*},(\cdot, \cdot)\right)$ by isometries. Denote its generators by $s_{i}$ for $i \in I$. The length function on $W$ will be written as $l: W \rightarrow \mathbb{Z}_{\geq 0}$. The Bruhat order will be denoted by $\geq$. Let $\Delta_{+} \subset Q_{+}$be the set of positive roots of $\mathfrak{g}$.

Let $\mathfrak{n}_{+}$and $\mathfrak{n}_{-}$denote the Lie subalgebras of $\mathfrak{g}$ generated by $\left\{e_{i} \mid i \in I\right\}$ and $\left\{f_{i} \mid i \in I\right\}$. So

$$
\mathfrak{n}_{ \pm}=\bigoplus_{\alpha \in \Delta_{+}} \mathfrak{g}^{ \pm \alpha}
$$

where $\mathfrak{g}^{\alpha}$ is the root space in $\mathfrak{g}$ corresponding to $\alpha$. The root spaces are one dimensional for real roots; that is roots in $W\left\{\alpha_{i} \mid i \in I\right\}$. For $w \in W$, we denote the nilpotent Lie subalgebras

$$
\mathfrak{n}_{ \pm}(w):=\bigoplus_{\alpha \in \Delta_{+} \cap w^{-1}\left(-\Delta_{+}\right)} \mathfrak{g}^{ \pm \alpha}
$$

If $w$ has a reduced expression $w=s_{i_{1}} \cdots s_{i_{N}}$, then $\mathfrak{n}_{+}(w)$ is generated by the root vectors corresponding to the real roots $\alpha_{i_{1}}, s_{i_{1}}\left(\alpha_{i_{2}}\right), \ldots, s_{i_{1}} \ldots s_{i_{N-1}}\left(\alpha_{i_{N}}\right)$.

Let $U_{q}(\mathfrak{g})$ be the corresponding quantized universal enveloping algebra defined over $\mathbb{Q}(q)$, which is generated by $e_{i}, f_{i}$, and $q^{h}$ for $i \in I, h \in \mathfrak{h}$ subject to the relations

$$

q^{0}=1, \quad q^{h} q^{h^{\prime}}=q^{h+h^{\prime}}, \quad q^{h} e_{i} q^{-h}=q^{\left\langle h, \alpha_{i}\right\rangle} e_{i}, \quad q^{h} f_{i} q^{-h}=q^{-\left\langle h, \alpha_{i}\right\rangle} f_{i}, \\
{\left[e_{i}, f_{i}\right]=\delta_{i j} \frac{q^{d_{i} h_{i}}-q^{-d_{i} h_{i}}}{q_{i}-q_{i}^{-1}},} \\
\sum_{s=0}^{1-a_{i j}}(-1)^{s}\left[\begin{array}{c}
1-a_{i j} \\
s
\end{array}\right]_{i} e_{i}^{1-a_{i j}-s} e_{j} e_{i}^{s}=0, \quad \sum_{s=0}^{1-a_{i j}}(-1)^{s}\left[\begin{array}{c}

\end{array}\right]_{i} f_{i}^{1-a_{i j}-s} f_{j} f_{i}^{s}=0, \quad i \neq j
\end{gathered}

for $h, h^{\prime} \in \mathfrak{h}, i, j \in I$, where

q_{i}=q^{d_{i}}, \quad[n]_{i}=\frac{q_{i}^{n}-q_{i}^{-n}}{q_{i}^{n}-q_{i}^{-n}}, \quad[n]_{i}!=[n]_{i} \ldots[1]_{i}, \quad \text { and } \quad\left[\begin{array}{l}
n \\
s
\end{array}\right]_{i}=\frac{[n]_{i}!}{[n-s]_{i}![s]_{i}!}
$$

The standard Hopf algebra structure on $U_{q}(\mathfrak{g})$ has counit, coproduct, and antipode given by

\epsilon\left(q^{h}\right)=1, \quad \epsilon\left(e_{i}\right)=\epsilon\left(f_{i}\right)=0, \\
\Delta\left(q^{h}\right)=q^{h} \otimes q^{h}, \quad \Delta\left(e_{i}\right)=e_{i} \otimes 1+q^{d_{i} h_{i}} \otimes e_{i}, \quad \Delta\left(f_{i}\right)=f_{i} \otimes q^{-d_{i} h_{i}}+1 \otimes f_{i}, \\
S\left(q^{h}\right)=q^{-h}, \quad S\left(e_{i}\right)=-q^{-d_{i} h_{i}} e_{i}, \quad S\left(f_{i}\right)=-f_{i} q^{d_{i} h},
\end{gathered}
$$

where $h \in P^{\vee}$ and $i \in I$. The unital subalgebras generated by $\left\{e_{i} \mid i \in I\right\},\left\{q^{h} \mid h \in P^{\vee}\right\}$, and $\left\{f_{i} \mid i \in I\right\}$ will be denoted by $U_{q}\left(\mathfrak{n}_{+}\right), U_{q}(\mathfrak{h})$, and $U_{q}\left(\mathfrak{n}_{-}\right)$. The algebras $U_{q}\left(\mathfrak{b}_{ \pm}\right):=$ $U_{q}\left(\mathfrak{n}_{ \pm}\right) U_{q}(\mathfrak{h})$ are Hopf subalgebras of $U_{q}(\mathfrak{g})$.

For a $U_{q}(\mathfrak{g})$-module $V$ and $\mu \in P$, denote the root space $V_{\mu}:=\left\{v \in V \mid q^{h} \cdot v=\right.$ $\left.q^{\langle h, \mu\rangle} v, \forall h \in P^{\vee}\right\}$.

Let $\left\{T_{i} \mid i \in I\right\}$ be the standard generators of the braid group of $W$. For a reduced expression $s_{i_{1}} \ldots s_{i_{N}}$ of $w \in W$, let $T_{w}:=T_{i_{1}} \ldots T_{i_{N}}$ in the braid group of $W$ (this element is independent on choice of reduced expression). We use the same notation for Lusztig's braid group action [30] on $U_{q}(\mathfrak{g})$ and on integrable $U_{q}(\mathfrak{g})$-modules (i.e., modules $V$ on which $e_{i}$ and $f_{i}$ act locally nilpotent for $i \in I$ and $\left.V=\oplus_{\mu \in P} V_{\mu}\right)$. For $\mu \in P_{+}$, let $V(\mu)$ be the irreducible highest weight $U_{q}(\mathfrak{g})$-module with highest weight $\mu$, and $v_{\mu}$ be a highest weight vector of it. For $w \in W$, denote $v_{w \mu}=T_{w^{-1}}^{-1} v_{\mu}$. In $\left(V(\mu)_{w \mu}\right)^{*}$, let $\xi_{w \mu}$ be such that $\left\langle\xi_{w \mu}, v_{w \mu}\right\rangle=1$. The quantum minors (viewed as functionals on $U_{q}(\mathfrak{g})$ ) are defined as the matrix coefficients $\Delta_{u \mu, w \mu}:=c_{\xi_{u \mu}, v_{w \mu}}$ for $u, w \in W$ and $\mu \in P_{+}$. Note that $\Delta_{u \mu, w \mu} \Delta_{u \nu, w \nu}=\Delta_{u(\mu+\nu), w(\mu+\nu)}$ since $T_{w^{-1}}^{-1}\left(v_{\mu} \otimes v_{\nu}\right)=T_{w^{-1}}^{-1} v_{\mu} \otimes T_{w^{-1}}^{-1} v_{\nu}$.
7.2. Hopf pairings and integral forms. Recall that a Hopf pairing between Hopf $\mathbb{K}$ algebras $A$ and $H$ is a bilinear form $(\cdot, \cdot): A \times H \rightarrow \mathbb{K}$ such that

for all $a, b \in A$ and $g, h \in H$ in terms of Sweedler notation.
Let $d \in \mathbb{Z}_{>0}$ be an integer such that $\left(P^{\vee}, P^{\vee}\right) \subseteq \mathbb{Z} / d$. The Rosso-Tanisaki form $(\cdot, \cdot)_{R T}$ : $U_{q}\left(\mathfrak{b}_{-}\right) \times U_{q}\left(\mathfrak{b}_{+}\right) \rightarrow \mathbb{Q}\left(q^{1 / d}\right)$ is the Hopf pairing defined by

\left(f_{i}, e_{j}\right)_{R T}=\delta_{i j} \frac{1}{q_{i}^{-1}-q_{i}},\left(q^{h}, q^{h^{\prime}}\right)_{R T}=q^{-\left(h, h^{\prime}\right)},\left(f_{i}, q^{h}\right)_{R T}=0=\left(q^{h}, e_{i}\right)_{R T}
$$

for all $i \in[1, r]$ and $h \in P^{\vee}$. The Rosso-Tanisaki form has the following useful properties,

& \left(x q^{h}, y q^{h^{\prime}}\right)_{R T}=(x, y)_{R T} q^{-\left(h, h^{\prime}\right)}, \\
& \quad\left(U_{q}\left(\mathfrak{n}_{-}\right), U_{q}\left(\mathfrak{n}_{+}\right)\right)_{R T} \subset \mathbb{Q}(q),  \tag{7.1}\\
& \text { and }\left(U_{q}\left(\mathfrak{n}_{-}\right)_{-\gamma}, U_{q}\left(\mathfrak{n}_{+}\right)_{\delta}\right)_{R T}=0
\end{align*}
$$

for $x \in U_{q}\left(\mathfrak{n}_{-}\right), y \in U_{q}\left(\mathfrak{n}_{+}\right)$, and $\gamma, \delta \in Q_{+}$with $\gamma \neq \delta$, see [25, Ch. 6].
Recall (2.2) and denote

$$
\mathcal{A}_{q}:=\mathbb{Z}\left[q^{ \pm 1}\right] .
$$

The divided power integral forms $U_{q}\left(\mathfrak{n}_{+}\right)_{\mathcal{A}_{q}}$ and $U_{q}\left(\mathfrak{n}_{-}\right)_{\mathcal{A}_{q}}$ of $U_{q}\left(\mathfrak{n}_{ \pm}\right)$are the $\mathcal{A}_{q}$-subalgebras generated by

\left\{e_{i}^{k} /[k]_{i}!\mid i \in I, k \in \mathbb{Z}_{>0}\right\} \quad \text { and } \quad\left\{f_{i}^{k} /[k]_{i}!\mid i \in I, k \in \mathbb{Z}_{>0}\right\}
$$

The dual integral form $U_{q}\left(\mathfrak{n}_{-}\right)_{\mathcal{A}_{q}}^{\vee}$ of $U_{q}\left(\mathfrak{n}_{-}\right)$is defined as

$$
U_{q}\left(\mathfrak{n}_{-}\right)_{\mathcal{A}_{q}}^{\vee}:=\left\{x \in U_{q}\left(\mathfrak{n}_{-}\right) \mid\left(x, U_{q}\left(\mathfrak{n}_{+}\right)_{\mathcal{A}_{q}}\right)_{R T} \subset \mathcal{A}_{q}\right\} .
$$

7.3. Quantum Schubert cells. Fixing a Weyl group element and a reduced expression $w=s_{i_{1}} \ldots s_{i_{N}}$, we denote the following elements of $W$ :

w_{\leq k}:=s_{i_{1}} \ldots s_{i_{k}}, w_{[j, k]}:=s_{i_{j}} \ldots s_{i_{k}}, w_{\leq k}^{-1}:=\left(w_{\leq k}\right)^{-1}, \text { and } w_{[j, k]}^{-1}:=\left(w_{[j, k]}\right)^{-1}
$$

where $0 \leq j \leq k \leq N$. To each root $\beta_{k}:=w_{\leq k-1}\left(\alpha_{i_{k}}\right) \in Q_{+}$for $k \in[1, N]$, associate the root vectors

e_{\beta_{k}}:=T_{w_{\leq k-1}^{-1}}^{-1}\left(e_{i_{k}}\right) \in U_{q}\left(\mathfrak{n}_{+}\right)_{\mathcal{A}_{q}} \quad \text { and } \quad f_{\beta_{k}}:=T_{w_{\leq k-1}^{-1}}^{-1}\left(f_{i_{k}}\right) \in U_{q}\left(\mathfrak{n}_{-}\right)_{\mathcal{A}_{q}}
$$

The quantum Schubert cells $U_{q}\left(\mathfrak{n}_{+}(w)\right)$ and $U_{q}\left(\mathfrak{n}_{-}(w)\right)$ are defined to be the unital $\mathbb{Q}(q)$ subalgebras of $U_{q}\left(\mathfrak{n}_{ \pm}\right)$generated by $e_{\beta_{1}}, \ldots, e_{\beta_{N}}$ and $f_{\beta_{1}}, \ldots, f_{\beta_{N}}$, respectively. They were defined by De Concini-Kac-Procesi [11] and Lusztig [30], who considered the antiisomorphic algebras $U_{q}^{ \pm}[w]=*\left(A_{q}\left(\mathfrak{n}_{ \pm}(w)\right)\right)$. It was proved in $[2,28,36]$ that

U_{q}\left(\mathfrak{n}_{ \pm}(w)\right)=U_{q}\left(\mathfrak{n}_{ \pm}\right) \cap T_{w^{-1}}^{-1}\left(U_{q}\left(\mathfrak{n}_{\mp}\right)\right) .
$$

The dual integral form of $U_{q}\left(\mathfrak{n}_{-}(w)\right)$ is the $\mathcal{A}_{q}$-algebra

$$
U_{q}\left(\mathfrak{n}_{-}(w)\right)_{\mathcal{A}_{q}}^{\vee}:=U_{q}\left(\mathfrak{n}_{-}(w)\right) \cap U_{q}\left(\mathfrak{n}_{-}\right)_{\mathcal{A}_{q}}^{\vee} .
$$

The dual PBW generators of $U_{q}\left(\mathfrak{n}_{-}(w)\right)$ are given by

f_{\beta_{k}}^{\prime}:=\frac{1}{\left(f_{\beta_{k}}, e_{\beta_{k}}\right)_{R T}} f_{\beta_{k}}=\left(q_{i_{k}}^{-1}-q_{i_{k}}\right) f_{\beta_{k}} \in U_{q}\left(\mathfrak{n}_{-}(w)\right)_{\mathcal{A}_{q}}
$$

for $k \in[1, N]$. Kimura proved [28, Proposition 4.26, Theorems 4.25 and 4.27] that

U_{q}\left(\mathfrak{n}_{-}(w)\right)_{\mathcal{A}_{q}}^{\vee}=\oplus_{m_{1}, \ldots, m_{N} \in \mathbb{N}} \mathcal{A}_{q} \cdot\left(f_{\beta_{1}}^{\prime}\right)^{m_{1}} \cdots\left(f_{\beta_{N}}^{\prime}\right)^{m_{N}} \tag{7.2}
\end{equation*}
$$

7.4. Quantum unipotent cells. Let $A_{q}\left(\mathfrak{n}_{+}\right)$, as in [19], denote the subalgebra of the full dual $U_{q}\left(\mathfrak{b}_{+}\right)^{*}$ of elements $f$ that satisfy the following conditions:
(1) $f\left(y q^{h}\right)=f(y)$ for any $y \in U_{q}\left(\mathfrak{n}_{+}\right)$and $h \in P^{\vee}$.
(2) There is a finite subset $S \subseteq Q_{+}$, such that $f(x)=0$ for all $x \in U_{q}\left(\mathfrak{n}_{+}\right)_{\gamma}$ for $\gamma \in Q_{+} \backslash S$.

The map $\iota: U_{q}\left(\mathfrak{n}_{-}\right) \rightarrow U_{q}\left(\mathfrak{b}_{+}\right)^{*}$ given by

$$
\langle\iota(x), y\rangle=(x, y)_{R T} \quad \text { for all } \quad x \in U_{q}\left(\mathfrak{n}_{-}\right), y \in U_{q}\left(\mathfrak{b}_{+}\right)
$$

is an algebra homomorphism because the Rosso-Tanisaki form is a Hopf pairing. The image of $\iota$ is contained in $A_{q}\left(\mathfrak{n}_{+}\right)$by the properties listed in (7.1). Since the Rosso-Tanisaki form is non-degenerate, $\iota$ is an isomorphism onto $A_{q}\left(\mathfrak{n}_{+}\right)$,

$$
\iota: U_{q}\left(\mathfrak{n}_{-}\right) \xrightarrow{\simeq} A_{q}\left(\mathfrak{n}_{+}\right) .
$$

Following Geiß-Leclerc-Schröer [19], define the quantum unipotent cell $A_{q}\left(\mathfrak{n}_{+}(w)\right) \subseteq$ $A_{q}\left(\mathfrak{n}_{+}\right)$as the image of $U_{q}\left(\mathfrak{n}_{-}(w)\right) \subseteq U_{q}\left(\mathfrak{n}_{-}\right)$under $\iota$,

$$
\iota: U_{q}\left(\mathfrak{n}_{-}(w)\right) \xrightarrow{\simeq} A_{q}\left(\mathfrak{n}_{+}(w)\right) \subset A_{q}\left(\mathfrak{n}_{+}\right) .
$$

The images of the elements of $U_{q}\left(\mathfrak{n}_{-}(w)\right)$ in $A_{q}\left(\mathfrak{n}_{+}(w)\right)$ will be denoted by the same symbols. We transport the automorphisms $T_{i}$ via $\iota$ to a partial braid group action on $A_{q}\left(\mathfrak{n}_{+}(w)\right)$. Quantum unipotent cells also inherit a $Q_{+}$-grading

A_{q}\left(\mathfrak{n}_{+}(w)\right)_{\gamma}:=\iota\left(U_{q}\left(\mathfrak{n}_{-}(w)\right)_{-\gamma}\right) \quad \text { for all } \quad \gamma \in Q_{+} . \tag{7.3}
\end{equation*}
$$

Finally, the dual integral form of $U_{q}\left(\mathfrak{n}_{-}(w)\right)$ gives rise to an $\mathcal{A}_{q}$-integral form of the quantum unipotent cell $A_{q}\left(\mathfrak{n}_{+}(w)\right)$,

A_{q}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{q}}:=\iota\left(U_{q}\left(\mathfrak{n}_{-}(w)\right)_{\mathcal{A}_{q}}^{\vee}\right)

The restriction of $\iota$ gives rise to the $\mathcal{A}_{q}$-algebra isomorphism

$$
\begin{equation*}
\iota: U_{q}\left(\mathfrak{n}_{-}(w)\right)_{\mathcal{A}_{q}}^{\vee} \xrightarrow{\simeq} A_{q}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{q}} . \tag{7.4}
\end{equation*}
$$

The integral forms $U_{q}\left(\mathfrak{n}_{-}\right)_{\mathcal{A}_{q}}^{\vee}, U_{q}\left(\mathfrak{n}_{-}(w)\right)_{\mathcal{A}_{q}}$ and $A_{q}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{q}}$ are often defined by using the Kashiwara [26] and Lusztig [30] bilinear forms on $U_{q}\left(\mathfrak{n}_{-}\right)$instead of the Rosso-Tanisaki form. However, the corresponding $\mathcal{A}_{q}$-algebras are isomorphic [24, Remark 5.3].

Following [19], define the unipotent quantum minors of $A_{q}\left(\mathfrak{n}_{+}(w)\right)$ for $u \in W, \mu \in P_{+}$as the elements of $A_{q}\left(\mathfrak{n}_{+}(w)\right)_{(u-w) \mu}$ such that

$$
\left\langle D_{u \mu, w \mu}, y q^{h}\right\rangle:=\left\langle\xi_{u \mu}, y v_{w \mu}\right\rangle
$$

for all $y \in U_{q}\left(\mathfrak{n}_{+}\right)$and $h \in P^{\vee}$. The quantum minors $\Delta_{u \mu, w \mu} \in A_{q}(\mathfrak{g})$ only depend on $u \mu$ and $w \mu$ but not on the individual choice of $w, u$ and $\mu,[4, \S 9.3]$. Since the unipotent minors $D_{u \mu, w \mu}$ can be realized as homomorphic images of them [24, $\left.\S 6.3\right]$, the same is true for them. The minors $D_{\mu, w \mu} q$-commute with homogeneous elements with respect to the $Q_{+}$-grading [24, Eq. (6.9)]:

7.5. Specialization to roots of unity. Recall (3.1) and denote

For every symmetrizable Kac-Moody algebra $\mathfrak{g}$ and Weyl group element $w \in W$, define the (integral) quantum unipotent cell at root of unity to be the $\mathcal{A}_{\varepsilon}$-algebra

A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}:=A_{q}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{q}} /(q-\varepsilon) A_{q}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{q}} .
$$

Denote the canonical projection

$$
\begin{equation*}
\eta_{\varepsilon}: A_{q}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{q}} \rightarrow A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}} \tag{7.6}
\end{equation*}
$$

and for $j \in[1, N]$ set

$$
\begin{equation*}
f_{\beta_{j}}^{\prime \prime \prime}:=\eta_{\varepsilon} \iota\left(f_{\beta_{j}}^{\prime}\right) \in A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}} \tag{7.7}
\end{equation*}
$$

By Kimura's result in (7.2) and the isomorphism (7.4), we have

$$
\begin{equation*}
A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}=\oplus_{m_{1}, \ldots, m_{N} \in \mathbb{N}} \mathcal{A}_{\varepsilon} \cdot\left(f_{\beta_{1}}^{\prime \prime}\right)^{m_{1}} \cdots\left(f_{\beta_{N}}^{\prime \prime}\right)^{m_{N}} \tag{7.8}
\end{equation*}
$$

Theorem 7.1. (De Concini-Kac-Procesi [11]) For every symmetrizable Kac-Moody algebra $\mathfrak{g}$, Weyl group element $w \in W$, and primitive $\ell$-th root of unity $\varepsilon$ such that $\ell$ is coprime to $\left\{d_{i} \mid i \in I\right\}$,

$$
C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}=\oplus_{m_{1}, \ldots, m_{N} \in \mathbb{N}} \mathcal{A}_{\varepsilon} \cdot\left(f_{\beta_{1}}^{\prime \prime}\right)^{m_{1} \ell} \cdots\left(f_{\beta_{N}}^{\prime \prime}\right)^{m_{N} \ell}
$$

is a central $\mathcal{A}_{\varepsilon}$-subalgebra of $A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$.
The theorem was proved in [11] in the case when $\mathfrak{g}$ is finite dimensional, but the same proof works for general symmetrizable Kac-Moody algebras. Alternatively, in the case when $\ell$ is odd, this theorem also follows by combining Proposition 4.4 and Theorem 8.5 (we note that the proof of Theorem 8.5 does not use Theorem 7.1).

## 8. Discriminants of quantum unipotent cells at roots of unity

In this section we obtain an explicit formula for the discriminant of each (integral) quantum unipotent cell $A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$ over the central subalgebra $C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$ for every symmetrizable Kac-Moody algebra $\mathfrak{g}$ and Weyl group element $w$. It is also proved that the algebras $A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$ posses a strict root of unity quantum cluster algebra structure. In this picture we give an intrinsic interpretation of the central subalgebras $C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$ in cluster algebra terms.
8.1. Theorem on discriminants of quantum unipotent cell. For a Weyl group element $w$ denote its support $\mathcal{S}(w):=\left\{i \in I \mid s_{i} \leq w\right\}$.

It follows from (7.8) and the definition of $C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$ that $A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$ is a free module over $C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$ of rank $\ell^{N}$ with basis

$$
\begin{equation*}
\left\{\left(f_{\beta_{1}}^{\prime \prime}\right)^{m_{1}} \ldots\left(f_{\beta_{N}}^{\prime \prime}\right)^{m_{N}} \mid m_{1}, \ldots, m_{N} \in[0, \ell-1]\right\} \tag{8.1}
\end{equation*}
$$

The corresponding discriminant is given by:
Theorem 8.1. Let $\mathfrak{g}$ be a symmetrizable Kac-Moody algebra, w be a Weyl group element with a reduced expression $w=s_{i_{1}} \ldots s_{i_{N}}$, and $\ell>2$ be an odd integer which is coprime to $d_{i}$ for all $i \in \mathcal{S}(w)$. Let $\varepsilon$ be a primitive $\ell$-th root of unity. Then

$$
d\left(A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}} / C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}\right)==_{\mathcal{A}_{\varepsilon}^{\times}} \ell^{\left(N \ell^{N}\right)} \prod_{i \in \mathcal{S}(w)} \eta_{\varepsilon}\left(D_{\varpi_{i}, w \varpi_{i}}\right)^{\ell^{N}(\ell-1)} .
$$

Note that, since $C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$ is a polynomial algebra over $\mathcal{A}_{\varepsilon}, C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}=\mathcal{A}_{\varepsilon}^{\times}$. The theorem is proved in $\S 8.5$.
8.2. Cluster structures of the integral forms of quantum unipotent cells. For the construction of strict root of unity quantum cluster structure on $A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$ we will use results from $[24,27]$ on a quantum cluster algebra structure on

A_{q}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{q}^{1 / 2}}:=A_{q}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{q}} \otimes_{\mathcal{A}_{q}} \mathcal{A}_{q}^{1 / 2} .
$$

Fix a reduced expression $w=s_{i_{1}} \ldots s_{i_{N}}$. In terms of the support of $w$, it is given by $\mathcal{S}(w)=\left\{t \in I \mid t=i_{k}\right.$ for some $\left.k\right\}$. Let $p:[1, N] \rightarrow[1, N-1] \cup\{-\infty\}$ and $s:[1, N] \rightarrow$ $[2, N] \cup\{\infty\}$ be the predecessor and successor maps given by

$$
\begin{aligned}
p(k) & =\max \left\{j<k \mid i_{j}=i_{k}\right\} \text { where } \max \varnothing:=-\infty, \\
s(k) & =\min \left\{j>k \mid i_{j}=i_{k}\right\} \text { where } \min \varnothing:=\infty .
\end{aligned}
$$

The mutable directions in the cluster structure will be given by the subset

$$
\operatorname{ex}(w):=\left\{k \in[1, N] \mid i_{j}=i_{k} \text { for } j>k\right\} .
$$

It has cardinality $|\mathbf{e x}(w)|=N-|\mathcal{S}(w)|$ as each $t \in \mathcal{S}(w)$ in the support will have only one $j \in[1, N]$ such that $i_{j}=t$ and $s(j)=\infty$. Let $\widetilde{B}^{w}$ be the $N \times \mathbf{e x}(w)$ matrix with entries

$$
\left(\widetilde{B}^{w}\right)_{j, k}= \begin{cases}1, & \text { if } j=p(k) \\ -1, & \text { if } j=s(k) \\ a_{i_{j} i_{k}} & \text { if } j<k<s(j)<s(k) \\ -a_{i_{j} i_{k}} & \text { if } k<j<s(k)<s(j) \\ 0, & \text { otherwise }\end{cases}
$$

The principal part $B^{w}$ is skew-symmetrizable by the matrix $D:=\operatorname{diag}\left(d_{i_{j}}, j \in \operatorname{ex}(w)\right)$. Moreover, $\widetilde{B}^{w}$ is compatible with the skew-symmetric $N \times N$ matrix

$$
\left(\Lambda_{w}\right)_{j, k}:=-\left(\left(w_{\leq j}+1\right) \varpi_{i_{j}},\left(w_{\leq k}-1\right) \varpi_{i_{k}}\right), \quad \text { for } 1 \leq j<k \leq N,
$$

see [24, Proposition 7.2]. By (7.5), the unipotent quantum minors $D_{\varpi_{i_{k}}, w_{\leq k} \varpi_{i_{k}}}$, with weight $\left(1-w_{\leq k}\right) \varpi_{i_{k}}, q$-commute amongst themselves:

$$
D_{\varpi_{i_{j}}, w_{\leq j} \varpi_{i_{j}}} D_{\varpi_{i_{k}}, w_{\leq k} \varpi_{i_{k}}}=q^{\left(\Lambda_{w}\right)_{j, k}} D_{\varpi_{i_{k}}, w_{\leq k} \varpi_{i_{k}}} D_{\varpi_{i_{j}}, w_{\leq j} \varpi_{i_{j}}}, \quad 1 \leq N .
$$

There is a unique toric frame $M_{q}^{w}: \mathbb{Z}^{N} \rightarrow \operatorname{Fract}\left(A_{q}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{q}^{1 / 2}}\right) \simeq \operatorname{Fract}\left(\mathcal{T}_{q}\left(\Lambda_{w}\right)\right)$, with corresponding skew-symmetric matrix $\Lambda_{w}$, given by

$$
M_{q}^{w}\left(e_{k}\right)=q^{a[1, k]} D_{\varpi_{i_{k}}, w_{\leq k} \varpi_{i_{k}}} \text { for any } k \in[1, N]
$$

where

$$
\begin{equation*}
a[j, k]=\left\|\left(w_{[j, k]}-1\right) \varpi_{i_{k}}\right\|^{2} / 4 \in \mathbb{Z} / 2 . \tag{8.2}
\end{equation*}
$$

The above facts show that $\left(\Lambda_{w}, \widetilde{B}^{w}\right)$ is a compatible pair and that $\left(M_{q}^{w}, \widetilde{B}^{w}\right)$ is a quantum seed. The following theorem is proved in [24] and in [27] in the case of symmetric KacMoody algebras.

Theorem 8.2. Let $\mathfrak{g}$ be any symmetrizable Kac-Moody algebra and $w \in W$ a Weyl element with a reduced expression $w=s_{i_{1}} \ldots s_{i_{N}}$. Then the integral form of the corresponding quantum unipotent cells has a cluster structure, $A_{q}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{q}^{1 / 2}} \simeq \mathbf{A}_{q}\left(M_{q}^{w}, \widetilde{B}^{w}, \varnothing\right)$.

Denote by $\Xi_{N}$ the subset of the symmetric group $S_{N}$ consisting of permutations $\sigma$ such that $\sigma([1, k])$ is an interval for $1 \leq k \leq N$. We can combinatorially describe this subset in terms of one-line notation for the elements of $S_{N}$ : first move 1 as far right as desired, then move 2 as far right as desired up to where 1 now is, then moving 3 right possibly up to 2 , etc. The elements of $S_{N}$ obtained in this way are precisely those of $\Xi_{N}$. The following diagram illustrates this with arrows denoting pairs of elements of $\Xi_{N}$ obtained from each other by a transposition:

For each $\sigma \in \Xi_{N},\left[24\right.$, Theorem 7.3(b)] constructs a quantum seed of $\mathbf{A}_{q}\left(M_{q}^{w}, \widetilde{B}^{w}, \varnothing\right)$. Their toric frames (up to a permutation of the basis as below) have cluster variables

\begin{equation*}
M_{q, \sigma}^{w}\left(e_{l}\right)=q^{a[j, k]} D_{w_{\leq j-1} \varpi_{i_{k}}, w_{\leq k} \varpi_{i_{k}}}=q^{a[j, k]} T_{w_{\leq j-1}} D_{\varpi_{i_{k}}, w_{[j, k]} \varpi_{i_{k}}}, \tag{8.3}
\end{equation*}
$$

where $j=\min \left\{m \in \sigma([1, l]) \mid i_{m}=i_{\sigma(l)}\right\}, k=\max \left\{m \in \sigma([1, l]) \mid i_{m}=i_{\sigma(l)}\right\}$ and $a[j, k]$ are given by (8.2). In particular, $M_{q, \text { id }}^{w}=M_{q}^{w}$. The exchange matrices of these seeds will not play a role in this paper. By abuse of notation we will denote by $\Xi_{N}$ this collection of quantum seeds of $\mathbf{A}_{q}\left(M_{q}^{w}, \widetilde{B}^{w}, \varnothing\right)$.

By [24, Theorem $7.3(\mathrm{c})]$ this collection of quantum seeds of $A_{q}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{q}^{1 / 2}}$ is linked by mutations as follows. Let $\sigma, \sigma^{\prime} \in \Xi_{N}$ be such that $\sigma^{\prime}=(\sigma(k), \sigma(k+1)) \circ \sigma=\sigma \circ(k, k+1)$ for $k \in[1, N-1]$.

$$
\begin{align*}
& \text { If } i_{\sigma(k)} \neq i_{\sigma(k+1)} \text {, then } M_{q, \sigma^{\prime}}^{w}=M_{q, \sigma}^{w} \cdot(k, k+1) ; \\
& \text { If } i_{\sigma(k)}=i_{\sigma(k+1)} \text {, then } M_{q, \sigma^{\prime}}^{w}=\mu_{k}\left(M_{q, \sigma}^{w}\right), \tag{8.4}
\end{align*}
$$

where we use the canonical action of $S_{N}$ on quantum seeds and toric frames by reordering of basis elements given by $M_{q} \cdot \sigma\left(e_{j}\right):=M_{q}\left(e_{\sigma(j)}\right)$ for $\sigma \in S_{N}$ and $1 \leq j \leq N$.

The following lemma is simple and is left to the reader:
Lemma 8.3. The collection of quantum seeds $\Xi_{N}$ of $\mathbf{A}_{q}\left(M_{q}^{w}, \widetilde{B}^{w}, \varnothing\right)$ is a nerve.
8.3. Root of unity quantum cluster structure on integral quantum unipotent cells. Assume that $\varepsilon^{1 / 2}$ is a primitive $\ell$-th root of unity. Denote

$$
A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}^{1 / 2}}:=A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}} \otimes_{\mathcal{A}_{\varepsilon}} \mathcal{A}_{\varepsilon}^{1 / 2}
$$

In the case when $\ell$ is odd, $\varepsilon$ is also a primitive $\ell$-th root of of unity, $\mathcal{A}_{\varepsilon}^{1 / 2}=\mathcal{A}_{\varepsilon}$, and $A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}^{1 / 2}} \cong A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$. In the case when $\ell$ is even, $\varepsilon$ is a primitive $(\ell / 2)$-th root of unity. Consider the canonical extension of the specialization (7.6) to a specialization map

$$
\eta_{\varepsilon}: A_{q}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{q}^{1 / 2}} \rightarrow A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}^{1 / 2}} \simeq A_{q}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{q}^{1 / 2}} /\left(\Phi_{\ell}\left(q^{1 / 2}\right)\right)
$$

such that $q^{1 / 2} \mapsto \varepsilon^{1 / 2}$. By [24, Theorem 7.3(a)]

$$
\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}^{w}, \Lambda_{w}, \widetilde{B}^{w}, \varnothing\right)=\mathbf{U}_{\varepsilon}\left(M_{\varepsilon}^{w}, \Lambda_{w}, \widetilde{B}^{w}, \varnothing\right),
$$

so we are in a position to apply Theorem 5.11. Firstly, this gives that the maps

$$
M_{\varepsilon, \sigma}^{w}:=\eta_{\varepsilon} \circ M_{q, \sigma}^{w}: \mathbb{Z}^{N} \rightarrow A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}^{1 / 2}}
$$

are toric frames for all $w \in W$ and $\sigma \in \Xi_{N}$. Secondly, we obtain that

$$
A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}^{1 / 2}} \simeq \mathbf{A}_{\varepsilon}\left(M_{\varepsilon}^{w}, \Lambda_{w}, \widetilde{B}^{w}, \varnothing\right)
$$

This leads to the following theorem:
Theorem 8.4. For every symmetrizable Kac-Moody algebra $\mathfrak{g}$, a Weyl group element $w$ with a reduced expression $w=s_{i_{1}} \ldots s_{i_{N}}$, and a primitive $\ell$-th root of unity $\varepsilon^{1 / 2}$ for $\ell \in \mathbb{Z}_{+}$, the following hold:
(1) $A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}^{1 / 2}}$ has the structure of strict root of unity quantum cluster algebra and is isomorphic to $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}^{w}, \Lambda_{w}, \widetilde{B}^{w}, \varnothing\right)$.
(2) The root of unity quantum cluster algebra in part (1) has seeds indexed by $\sigma \in \Xi$ with toric frames $M_{\varepsilon, \sigma}^{w}$.
(3) The collection of seeds in part (2), to be denoted by $\Xi_{N}$, is a nerve and we have the mutation formulas (8.4) between them with $M_{q, \sigma}^{w}$ replaced by $M_{\varepsilon, \sigma}^{w}$.
(4) Under the isomorphism in part (1), $A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}^{1 / 2}}=\mathbf{A}_{\varepsilon}\left(\Xi_{N}, \varnothing\right)$.

Proof. Parts (1) and (2) are established above.
(3) The mutations formulas (8.4) with $M_{q, \sigma}^{w}$ replaced by $M_{\varepsilon, \sigma}^{w}$ follow from the original formulas (8.4) by applying the ring homomorphism $\eta_{\varepsilon}$. It follows from Lemma 8.3 that $\Xi_{N}$ is a nerve.
(4) It is clear that, under the isomorphism in part (1), $\mathbf{A}_{\varepsilon}\left(\Xi_{N}, \varnothing\right) \subseteq \mathbf{A}_{\varepsilon}\left(M_{\varepsilon}^{w}, \Lambda_{w}, \widetilde{B}^{w}, \varnothing\right)=$ $A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}^{1 / 2}}$. For the inverse inclusion, note that for each $k \in[1, N]$, there exists $\sigma \in \Xi_{N}$ such that $\sigma(1)=k$. For that $\sigma$ we have

$$
M_{q, \sigma}^{w}\left(e_{1}\right)=q_{i_{k}}^{1 / 2} \iota\left(f_{\beta_{k}}^{\prime}\right)
$$

by combining [24, Eq. (3.6), (7.2) and Theorem7.1(c)], and thus

$$
\begin{equation*}
M_{\varepsilon, \sigma}^{w}\left(e_{1}\right)=\varepsilon_{i_{k}}^{d_{i_{k}} / 2} f_{\beta_{k}}^{\prime \prime} . \tag{8.5}
\end{equation*}
$$

Hence, under the isomorphism in part (1), $\mathbf{A}_{\varepsilon}\left(\Xi_{N}, \varnothing\right) \supseteq A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}^{1 / 2}}$, which completes the proof of the theorem.
8.4. Identification of central subalgebras. Let $\varepsilon$ be a primitive $\ell$-th root of unity such that $\ell$ is odd and coprime to the symmetrizing integers $d_{i}$ for the Kac-Moody algebra $\mathfrak{g}$ and $i \in \mathcal{S}(w), w \in W$. Choose a square root $\varepsilon^{1 / 2}$ of $\varepsilon \operatorname{such}$ that $\varepsilon^{1 / 2}$ is also a primitive $\ell$-th root of unity. Then $\mathcal{A}_{\varepsilon}=\mathcal{A}_{\varepsilon}^{1 / 2}$. By Theorem 8.4 we have the identifications

$$
A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}=A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}^{1 / 2}}=\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}^{w}, \Lambda_{w}, \widetilde{B}^{w}, \varnothing\right)=\mathbf{A}_{\varepsilon}\left(\Xi_{N}, \varnothing\right) .
$$

On the one hand, we have the central subalgebra $\mathbf{C}_{\varepsilon}\left(\Xi_{N}, \varnothing\right)$ of $\mathbf{A}_{\varepsilon}\left(\Xi_{N}, \varnothing\right)$ constructed by cluster theoretic methods, see $\S 6.2$. On the other hand, we have the De Concini-Kac-Procesi central subalgebra $C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$ of $A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$, see $\S 7.5$.

Theorem 8.5. In the setting of Theorem 8.1, the canonical central subalgebra $\mathbf{C}_{\varepsilon}\left(\Xi_{N}, \varnothing\right)$ of $\mathbf{A}_{\varepsilon}\left(\Xi_{N}, \varnothing\right)=A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$ coincides with the De Concini-Kac-Procesi central subalgebra $C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$.
Proof. It follows from (8.5) that $C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}} \subseteq \mathbf{C}_{\varepsilon}\left(\Xi_{N}, \varnothing\right)$. To show the reverse inclusion, we need to show that for all $\sigma \in \Xi_{N}$ and $j \in[1, N], M_{\varepsilon, \sigma}^{w}(j)^{\ell} \in C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$. By (8.3), this is equivalent to

$$
\begin{equation*}
\eta_{\varepsilon}\left(D_{w_{\leq j-1} \varpi_{i_{k}}, w_{\leq k} \varpi_{i_{k}}}^{\ell}\right) \in C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}, \quad \forall 1 \leq j \leq k \leq N \text { with } i_{j}=i_{k} \tag{8.6}
\end{equation*}
$$

We prove (8.6) by induction on $k-j$. The case $k-j=0$ is trivial since

$$
\eta_{\varepsilon}\left(D_{w_{\leq k-1} \varpi_{k_{k}}, w_{\leq k} \varpi_{i_{k}}}\right)=\varepsilon_{i_{k}}^{d_{i_{k}} / 2} f_{\beta_{k}}^{\prime \prime}
$$

by (8.5). Now assume that $k-j=t$ for some $t \in \mathbb{Z}_{+}$and that the statement holds for pairs $1 \leq j^{\prime} \leq k^{\prime} \leq N$ with $k^{\prime}-j^{\prime}<t$. Since $i_{j}=i_{k}, j \leq p(k)$ and $s(j) \leq k$. Consider the following elements of $\Xi_{N}$ :

$$
\begin{aligned}
\sigma & =[j+1, \ldots, k-1, j, k, k+1, \ldots, N, 1 \ldots, j-1] \text { and } \\
\sigma^{\prime} & =[j+1, \ldots, k-1, k, j, k+1, \ldots N, 1, \ldots, j-1]=\sigma(k-j, k-j+1)
\end{aligned}
$$

in the two line notation for elements of $S_{N}$. By (8.4), $M_{\varepsilon, \sigma^{\prime}}^{w}=\mu_{k-j} M_{\varepsilon, \sigma^{*}}^{w}$. From [23, Theorem 6.6] we have that the $(k-j)$-th column of the exchange matrix of the root of unity quantum seed of $A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}^{1 / 2}}$ corresponding to $\sigma$ has the form $\left(b_{1}, \ldots, b_{N}\right)^{\top}$ with

$$
\begin{aligned}
& b_{k-j+1}=-1, \quad b_{p(k)-j}=-1 \text { if } j \leq p(k), \\
& b_{i} \geq 0 \text { for } i<k-j, i \neq p(k)-j, \\
& b_{i}=0 \quad \text { otherwise. }
\end{aligned}
$$

Combining this with Proposition 4.4 gives
$M_{\varepsilon, \sigma^{\prime}}^{w}\left(e_{k-j}\right)^{\ell}=\left(\mu_{k-j} M_{\varepsilon, \sigma}^{w}\left(e_{k-j}\right)\right)^{\ell}=M_{\varepsilon, \sigma}^{w}\left(e_{k-j}\right)^{-\ell}\left(M_{\varepsilon, \sigma}^{w}\left(e_{k-j+1}\right)^{\ell} M^{\ell}+\prod_{i<k-j, b_{i}>0} M_{\varepsilon, \sigma}^{w}\left(e_{i}\right)^{\ell}\right)$ where

$$
M^{\ell}:= \begin{cases}M_{\varepsilon, \sigma}^{w}\left(e_{p(k)-j}\right)^{\ell}, & \text { if } j \leq p(k) \\ 1, & \text { otherwise } .\end{cases}
$$

It follows from (8.3) that $M_{\varepsilon, \sigma}^{w}\left(e_{k-j+1}\right)^{\ell}=\eta_{\varepsilon}\left(D_{w_{\leq j-1} \varpi_{i_{k}}, w_{\leq k} \varpi_{i_{k}}}^{\ell}\right)$ and that $M_{\varepsilon, \sigma^{\prime}}^{w}\left(e_{k-j}\right)^{\ell}$ and $M_{\varepsilon, \sigma}^{w}\left(e_{i}\right)^{\ell}$ for $i \leq k-j$ are of the form $\eta_{\varepsilon}\left(D_{w_{\leq j^{\prime}-1} \omega_{i_{k^{\prime}}}, w_{\leq k^{\prime}} \omega_{i_{k^{\prime}}}}^{\ell}\right)$ for pairs $1 \leq j^{\prime} \leq k^{\prime} \leq N$ with $k^{\prime}-j^{\prime}<k-j$. The induction assumption implies that

$$
\eta_{\varepsilon}\left(D_{w_{\leq j-1} \varpi_{i_{k}}, w_{\leq k} \varpi_{i_{k}}}\right) \in \operatorname{Fract}\left(C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}\right) \cap A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}} .
$$

It remains to prove that

$$
\begin{equation*}
\operatorname{Fract}\left(C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}\right) \cap A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}=C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}} . \tag{8.7}
\end{equation*}
$$

Let

$$
P=\sum p_{m_{1}, \ldots, m_{N}}\left(f_{\beta_{1}}^{\prime \prime}\right)^{m_{1} \ell} \ldots\left(f_{\beta_{N}}^{\prime \prime}\right)^{m_{N} \ell}, \quad Q=\sum q_{m_{1}, \ldots, m_{N}}\left(f_{\beta_{1}}^{\prime \prime}\right)^{m_{1} \ell} \ldots\left(f_{\beta_{N}}^{\prime \prime}\right)^{m_{N} \ell}
$$

and

$$
R=\sum r_{n_{1}, \ldots, n_{N}}\left(f_{\beta_{1}}^{\prime \prime}\right)^{n_{1}} \ldots\left(f_{\beta_{N}}^{\prime \prime}\right)^{n_{N}}
$$

be such that $P=R Q$. Since $f_{\beta_{i}}^{\prime \prime}$ are in the center of $A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$,

$$
Q R=\sum r_{n_{1}, \ldots, n_{N}} q_{m_{1}, \ldots, m_{N}}\left(f_{\beta_{1}}^{\prime \prime}\right)^{n_{1}+m_{1} \ell} \ldots\left(f_{\beta_{N}}^{\prime \prime}\right)^{n_{m}+m_{N} \ell}
$$

In light of the PBW basis (7.8), the identity $P=Q R$ implies that $r_{n_{1}, \ldots, n_{N}}=0$ unless $n_{1}, \ldots, n_{N}$ are divisible by $\ell$. This proves (8.7).
8.5. Proof of Theorem 8.1. As in the previous subsection we chose a square root $\varepsilon^{1 / 2}$ of $\varepsilon$ such that $\varepsilon^{1 / 2}$ is also a primitive $\ell$-th root of unity. In particular, $\mathcal{A}_{\varepsilon}=\mathcal{A}_{\varepsilon}^{1 / 2}$. By Theorems 8.4 and 8.5 we have the identifications

$$
\begin{aligned}
& A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}=A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}^{1 / 2}}=\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}^{w}, \Lambda_{w}, \widetilde{B}^{w}, \varnothing\right)=\mathbf{A}_{\varepsilon}\left(\Xi_{N}, \varnothing\right) \quad \text { and } \\
& \mathbf{C}_{\varepsilon}\left(\Xi_{N}, \varnothing\right)=C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}} .
\end{aligned}
$$

Since we are requiring that $\ell$ is coprime to all $d_{i_{k}}$ for $1 \leq k \leq N$, the root of unity quantum seeds of $\mathbf{A}_{\varepsilon}\left(M_{\varepsilon}^{w}, \Lambda_{w}, \widetilde{B}^{w}, \varnothing\right)$ satisfy condition (Coprime). Its frozen variables are

$$
M_{\varepsilon}^{w}\left(e_{k}\right)=\varepsilon^{a[1, k]} \eta_{\varepsilon}\left(D_{\varpi_{i_{k}}, w \leq k}, \varpi_{i_{k}}\right)=\varepsilon^{a[1, k]} \eta_{\varepsilon}\left(D_{\varpi_{i_{k}}, w \varpi_{i_{k}}}\right) \quad \text { for } \quad k \in[1, N] \backslash \mathbf{e x},
$$

where the last equality holds because $w_{\leq k} \varpi_{i_{k}}=w \varpi_{i_{k}}$ for $k \in[1, N] \backslash \mathbf{e x}$. By the definitions of the sets ex and $\mathcal{S}(w)$, up to terms in $\mathcal{A}_{\varepsilon}^{\times}$, the frozen variables are

$$
\eta_{\varepsilon}\left(D_{\varpi_{i}, w \varpi_{i}}\right) \quad \text { for } \quad i \in \mathcal{S}(w) .
$$

Theorem 6.6 implies that

$$
\begin{equation*}
d\left(A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}} / C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}\right)==_{\mathcal{A}_{\varepsilon}^{\times}} \ell^{\left(N \ell^{N}\right)} \prod_{i \in \mathcal{S}(w)} \eta_{\varepsilon}\left(D_{\varpi_{i}, w \varpi_{i}}\right)^{n_{i}} \tag{8.8}
\end{equation*}
$$

for some $n_{i} \in \mathbb{N}$. Eq (6.1) and the fact that (8.1) is a basis of $A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$ over $C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$ imply that with respect to the $Q_{+}$-grading (7.3) of $A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}$,

$$
\begin{align*}
\operatorname{deg} d\left(A_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}} / C_{\varepsilon}\left(\mathfrak{n}_{+}(w)\right)_{\mathcal{A}_{\varepsilon}}\right) & =2 \sum_{0 \leq m_{k} \leq \ell-1} \operatorname{deg}\left(\left(f_{\beta_{1}}^{\prime \prime}\right)^{m_{1}} \cdots\left(f_{\beta_{N}}^{\prime \prime}\right)^{m_{N}}\right)  \tag{8.9}\\
& =\ell^{N}(\ell-1)\left(\beta_{1}+\cdots+\beta_{N}\right) .
\end{align*}
$$

For $k \in[1, N] \backslash \mathbf{e x}$, let $r_{k}$ is the maximal integer such that $p^{r_{k}}(k) \neq-\infty$. Iterating the identity $w_{\leq j} \varpi_{i_{j}}=w_{\leq j-1}\left(\varpi_{i_{j}}-\alpha_{i_{j}}\right)=w_{\leq p(j)} \varpi_{i_{j}}-\beta_{j}, \forall j \in[1, N]$ gives

$$
\beta_{p^{m_{k}}(k)}+\cdots+\beta_{k}=\left(1-w_{\leq k}\right) \varpi_{i_{k}}=(1-w) \varpi_{i_{k}}
$$

Therefore,

$$
\begin{equation*}
\beta_{1}+\cdots+\beta_{N}=\sum_{k \in[1, N] \backslash \mathbf{e x}}\left(\beta_{p^{r_{k}}(k)}+\cdots+\beta_{k}\right)=\sum_{i \in \mathcal{S}(w)}(1-w) \varpi_{i} . \tag{8.10}
\end{equation*}
$$

Combining (8.8)-(8.10) and using that $\operatorname{deg} \eta_{\varepsilon}\left(D_{\varpi_{i}, w \varpi_{i}}\right)=(1-w) \varpi_{i}$ leads to

$$
(1-w) \sum_{i \in \mathcal{S}(w)}\left(n_{i}-(\ell-1) \ell^{N}\right)=0 .
$$

This implies that $n_{i}=(\ell-1) \ell^{N}$ for all $i \in \mathcal{S}(w)$ because $(1-w)$ is nondegenerate on $\operatorname{Span}\left\{\varpi_{i} \mid i \in \mathcal{S}(w)\right\}$.
